Once in the vehicle, they transported him to his bank and demanded he withdrawn an additional \$800 from his account. Once the transaction was complete, the suspects dropped the victim off near his home and left the area. Investigations identified two suspects both as 20 year old males. Both males were located, and taken into custody, by Crystal PD. Both were questioned regarding the incident. Both were booked at the Hennepin County Jail for felony aggravated 1st degree robbery and felony kidnapping as well as the additional charge of felony possession of a controlled substance, against one of the two suspects.</p>
