Changes to Construction Schedule

Please be aware the construction schedule may change throughout the project as a result of weather conditions or other activities beyond the contractor's control. Should a major change in the schedule be anticipated, we will do our best to communicate the change through this newsletter and through your field contact, Justin Moeller.

Project Schedule Update

The Contractor has completed all temporary water transfers to businesses and residents along Stinson Blvd. and is continuing sanitary sewer and water main installation along Stinson Boulevard between Silver Ln and 39th Avenue. The contractor's top priority is to complete all utility installations at the intersection of Stinson Blvd and Silver Ln to open the intersection to traffic.

CenterPoint Energy has completed the replacement of gas main between Silver Ln and 38th Ave. CenterPoint Energy is anticipated to begin directionally drilling new steel gas main from the south side of 37th Ave to 38th Ave on Tuesday, May 3.

The following is an anticipated schedule of upcoming construction activities:

May 2—May 6

- Continue replacing sanitary sewer, water main, and storm sewer at the intersection of Stinson Blvd and Silver Ln. and continuing south.
- Remove and replace deficient sidewalk within Salo Park.

May 9-May 13

- Sanitary and water service installation between 39th Ave and Silver Ln.
- Begin sanitary sewer, water main, and storm sewer south of 39th Ave.
- Begin building road section between Silver Ln and 39th Ave (including drain tile and class 5 installation).

May 16—May 20

- Continue sanitary sewer, water main, and storm sewer south of 39th Ave including sanitary and water service installation.
