City News - Join a Commission



Saint Anthony Village is seeking engaged citizens to lend their voice and time to our Planning and Parks & Environmental Commissions. This is your opportunity to be a positive voice for the future of our community.

PLANNING COMMISSION: Commissioners advise City Council on zoning decisions, development plans and policies; and provide a forum for citizen input. There are two open seats and the commission meets the 3rd Tuesday monthly.

PARKS & ENVIRONMENTAL COMMISSION: This Advisory Body provides input on policies, practices and proposals around sustainable use and management of the city's environmental resources. There are three open seats and the commission meets quarterly on the first Monday in March, June, September, and December, with occasional additional meetings/worksessions throughout the year.

Applications for both commissions are now open. Deadline to apply is Nov. 12; interviews will be held Nov. 18. The term is three years and begins Jan. 1, 2025. Commissioners are paid per meeting. Visit our website (savmn.com/boardsandcommissions) for application and additional information.

ADMINISTRATION & FINANCE

How Does the City Determine the Annual Tax Levy?

The Truth in Taxation public hearing and the adoption of the upcoming year's budget and tax levy occur in December each year, but the process to determine this levy starts much earlier. This process begins with Goal Setting meetings in January, where the Mayor, Council, department directors, and consultants convene for three days of discussions focused on goal setting, financial management, and strategic planning.

During these sessions, the Council collaborates with staff to identify the year's main priorities, which will guide the planning of programs and services for the following year.

In February, a public hearing is held to inform residents about the budget process schedule and to offer them an opportunity to provide input. From February through April, City Council meetings and work sessions are held with the City Manager, Finance Director, and City Engineer to discuss the city's infrastructure needs and update the Street and Utility Improvements plan.

Between April and May, staff meetings with Department Heads focus on the operating and capital budgets, following the city's budget parameters. The standard parameters include:

- City revenues are budgeted at current run rates for sources that are subject to trends and conservative baseline estimates for recurring aids and charges for services.
- Expenses are budgeted at amounts that will maintain present level of City services.
- Liquor Fund transfers to the General Fund are based on liquor operating results from the previous 5-7 years and the long-term needs of the fund.

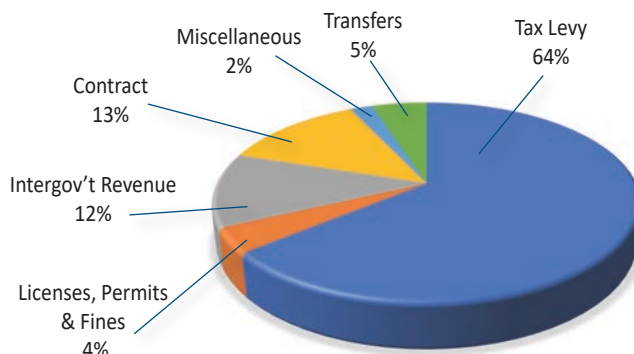
Throughout this period, and up until the final budget is adopted, staff continues to analyze actual costs with new information from vendors, service providers, and labor negotiations. Updated levy scenarios and detailed expense and revenue reports are presented to the council during work sessions and meetings from June through August.

At the second Council meeting in August, the proposed Operating Budget for the following year is presented to the City Council for final review. The preliminary levy is adopted at the first meeting in September, and the final levy, which legally cannot exceed the preliminary levy, is adopted at the first council meeting in December. The Truth in Taxation Public Hearing will be held Dec. 10 at 7pm in the Council Chambers.

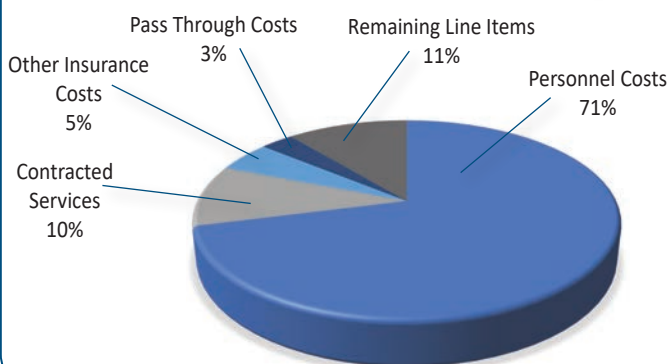
The 2025 preliminary levy was adopted at a 6% increase over the 2024 final adopted levy. Questions related to the City portion of the property tax bill can be directed to Finance Director Deborah Maloney 612-782-3316.

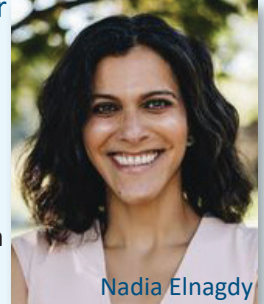

Both guides are online directories that provide disposal information specific to Ramsey or Hennepin County residents for hundreds of household items. Residents should use the county guide where you reside.

To use the [A to Z Green Guide](#), simply type in the item you want to dispose of using the search bar and a list of disposal options will appear, with the most environmentally-friendly options listed first. You can also suggest a new item by scrolling to the bottom of the page and clicking the button/text "Suggest [item name] as a new item." Staff will work to add it to the directory.

To use the [Green Disposal Guide](#), type in the item and/or related keywords to the item you want to dispose of and a list of results will appear with recommended disposal options listed first.

PARKS & ENVIRONMENTAL COMMISSION UPDATES

The commission (PEC) meets quarterly to make recommendations to City Council related to the sustainable use and management of Saint Anthony Village environmental resources. In 2024, the playground in Silver Point Park was replaced with a new fully accessible play structure, and the trail and parking lot were resurfaced.

Water Quality, Healthy Ecosystems and the City's Lakes

The PEC also works closely with several community organizations that seek to protect and repair our lakes, parks and surrounding environment. One organization, Friends of Silver Lake, is focused on the restoration of Silver Lake. This summer, Silver Lake was treated successfully for invasive Eurasian Milfoil and reseeding the lake with native plant species is being explored as a long-term mitigation. The organization is also asking lake shore homeowners and watershed residents to adopt an Organic First approach to help address

toxic runoff through using fewer synthetic fertilizers and chemical pesticides, as well as incorporating native landscapes and environmentally friendly management tools for their outdoor spaces. For more information and to get involved, visit silverlakeresidents.org/water-quality

Energy Savings Tips for Cooler Months



There are many things to love when welcoming fall, like cozy sweaters, pumpkin carving, and crisp air. But something we don't love is more expensive energy bills! As the daylight gets shorter and cooler temperatures require increased energy use, here are some energy-saving tips to try at home.

- Keep your thermostat at or below 68 degrees. According to the Department of Energy, setting the thermostat back 7-10 degrees for 8 hours a day can save up to 10% a year on heating costs.
- Make the most of your programmable or smart thermostat. Schedule your home temperature to be lower overnight or when you are routinely away from home. Scheduling temperature adjustments avoids energy waste.
- Perform furnace maintenance and replace filters. Make sure your heating system is operating properly and minimize the risk of breakdowns well before sub-zero temperatures arrive. A well-maintained furnace requires less energy to produce heat, saving energy and reducing utility costs over time.
- Eliminate drafts in doors, windows and other spaces. Seal and weatherize any cracks and gaps. Don't forget chimneys, keep the damper closed when not burning fires or consider energy-efficient fireplace grates to keep warm air from escaping.
- Let light and heat inside through the windows. Open blinds or curtains of south-facing windows to help warm a room during the day. And, keep curtains and blinds closed to trap heat in rooms that don't get much sunlight.
- Retrofit lighting fixtures with longer-lasting LED bulbs which are more energy efficient than traditional incandescent bulbs or fluorescent bulbs.

Neighborhood Fix-It Hub

Hennepin County's new program has landed at the St. Anthony Library (2941 Pentagon Drive).

A spin-off of the Fix-It Clinics, the **Neighborhood Fix-It Hub** is open every other Tuesday starting Oct. 8 from 4-7pm (last items accepted at 6:30 pm).

Participants can work with a skilled volunteer to try to fix broken household items, gain confidence, learn repair skills, and incorporate sustainability in everyday life. Bring an item that needs repair or come to watch and learn! All items brought to the Hub must be carry-in sized. This event is family friendly. If volunteers are limited, there may be a limit on the number of items that can be worked on each week.

October 12 Fix-It Clinic at City Hall

Work together with friendly, skilled volunteers to diagnose, troubleshoot and fix your stuff.

Fix-It Clinics teach valuable troubleshooting and basic repair skills, build community connections, and reduce the number of repairable things thrown in the trash.

Volunteers are always needed! Help keep the Fix-It Hub in our community by assisting with repairs and sewing.

PUBLIC SAFETY

Pedestrian Safety Tips for the Back-to-School Season

With students back in classrooms, it's important to remember that increased foot traffic around schools means heightened attention to pedestrian safety. To ensure a safe journey for everyone, here are some essential tips and reminders for students, parents, and drivers.

FOR STUDENTS

- 1. Use Crosswalks:** Always cross the street at designated crosswalks and wait for the pedestrian signal when available. Avoid jaywalking or crossing between parked cars.
- 2. Stay Alert:** Keep your head up and avoid distractions like texting or listening to music while crossing streets. Always make eye contact with drivers before stepping onto road.
- 3. Follow the Rules:** Obey traffic signals and signs. Wait for the "Walk" signal if available, and never start crossing if the signal is counting down.
- 4. Walk in Groups:** Whenever possible, walk with friends or family. There's safety in numbers, and it's more fun!
- 5. Be Visible:** Wear bright or reflective clothing, especially during early morning or late afternoon, and inclement weather when visibility is reduced.

FOR PARENTS

- 1. Educate Your Children:** Teach your children about the importance of pedestrian safety. Practice walking routes with them and discuss safe crossing practices.
- 2. Choose Safe Routes:** Plan your child's route to school, making sure it's safe and well-lit. Avoid routes with heavy traffic or no sidewalks.
- 3. Supervise Young Walkers:** For younger children, consider walking with them to school or ensuring they're supervised by a responsible adult.
- 4. Set a Good Example:** Model safe pedestrian behavior. Use crosswalks, obey traffic signals, and avoid using your phone while crossing streets.
- 5. Check Your Vehicle:** Ensure your vehicle is in good working condition and that you're aware of school zone rules, such as reduced speed limits.



FOR DRIVERS

- 1. Slow Down:** Reduce your speed in school zones and around crosswalks. Watch for school zone signs and adhere to posted speed limits.
- 2. Stay Focused:** Avoid distractions like mobile phones or in-car entertainment. Your full attention should be on the road, especially in heavily pedestrian areas.
- 3. Yield to Pedestrians:** Always yield to pedestrians at crosswalks and be prepared to stop for them. Be patient and never attempt to overtake a vehicle that has stopped for a pedestrian.
- 4. Watch for School Buses:** Observe school bus signals. Stop when a school bus has its stop sign extended and wait until the bus has moved and it's safe to proceed.
- 5. Be Mindful of Parking:** Avoid illegal parking in areas that could obstruct pedestrian visibility, such as near crosswalks or school entrances.

Smoke Alarms - Make them work for you

Week is Oct. 6-12**

Each year, the National Fire Protection Association (NFPA) celebrates Fire Prevention Week.

The week coincides with the anniversary of the Great Chicago Fire and is the longest running public health observance in our country. Fire Departments from all over use this time to educate the public on fire prevention. The National Fire Protection Association assists in this task by releasing a theme. This year's theme is *"Smoke Alarms: Make Them Work for You!"*

It's all about smoke alarms! National statistics from NFPA have shown that roughly three out of five fire deaths happen in homes with either no smoke alarms or no working smoke alarms. The risk of dying in a home fire is cut in half in homes with smoke alarms!

Here are some quick facts on smoke alarms for you and your family to stay safe:

- Smoke alarms need to be replaced every 10 years.
- Test all smoke alarms at least once a month using the test button found on the device. Replace batteries once a year.
- Smoke alarms with life-long batteries are designed to be effective for up to 10-years. If the alarm chirps, warning the battery is low, replace the alarm batteries right away.
- Install smoke alarms in every sleeping room and outside each separate sleeping area, and on every level of the home, including the basement.

PUBLIC SAFETY RECRUITMENT EFFORTS

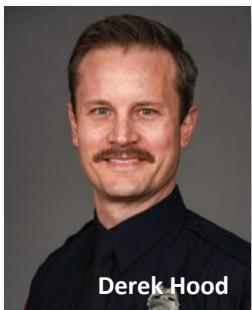

Pet Waste Reminder - Protect our Environment

With all the joys of having a pet, one of the not-so-glamorous parts is cleaning up after them. Pet waste left uncollected is not only unsightly but unsanitary with detrimental effects to human health and the environment.

When pet waste is washed away into our waterways, via our storm sewer systems, it depletes oxygen levels, and releases ammonia and excess nutrients; all of which contribute to unsightly weeds and algal blooms while harming fish and other aquatic organism populations. It also contains pathogenic bacteria and other parasites leading to health issues such as increased levels of Escherichia coli (E. coli) making lakes and rivers unsafe for swimming and recreational activities.

Please remember to take time at home to properly dispose of your pet's waste and be sure to bring along equipment like doggy bags to clean-up when you're on the go. It's up to us to keep our local waters clean!

Inflow & Infiltration Inspection Reminder

Two inspections are required prior to listing your home or business for sale:

- Sanitary sewer line inspection video
- Sump pump inspection

This ordinance is intended to help reduce peak sanitary sewer flows caused by Inflow and infiltration.

Inflow and Infiltration (I/I) is the excess flow of clear water into the City's sanitary sewer system. The system is not designed to handle excess clear water and it can become overloaded and cause basement flooding or bypass raw wastewater to local streams and lakes.



UPDATE: 2024 Street and Utility Improvement Project

The Contractor has substantially completed asphalt resurfacing for the 2024 Street Improvement Project. As the temperatures cool and precipitation increases with fall weather, the newly seeded areas where concrete curb was replaced will have optimal conditions to germinate and combat weeds.

Following establishment of the turf, we will continue to track the lawn restoration work and will be completing warranty inspections over the next two years. If something has not been completed, please call and we will do our best to get it addressed during the warrantee period. NEW: 2025 Street and Utility Improvement Project

Preparation of plans and specs are underway for the 2025 Street and Utility Improvement Project. The project includes complete street and utility reconstruction along MacAlaster Dr. from 39th Ave. to the railroad.

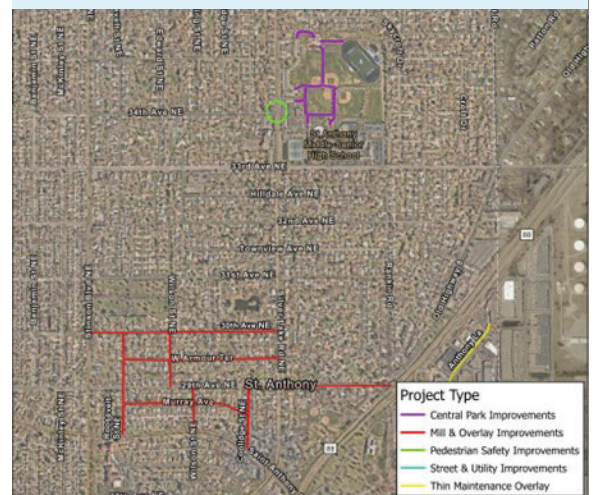
Proposed utility improvements include sanitary sewer and water main replacement with individual services to the right-of-way boundary, replacement of all hydrants, water valves, and manholes that do not meet current City standards, as well as new storm sewer and catch basins.

Additionally, the 2025 Street and Utility Improvement Project includes asphalt resurfacing (mill and overlay) improvements along the following roadways:

- 39th Ave. NE: Stinson Blvd. to Silver Lake Rd.
- 30th Ave. NE: Stinson Blvd. to Silver Lake Rd.
- Armour Terrace: Roosevelt St. to Silver Lake Rd.
- Murray Ave: Roosevelt St. to Coolidge St.
- 29th Ave. NE: Silver Lake Rd. to Highway 88
- Roosevelt St: St. Anthony Blvd. to 30th Ave. NE
- Wilson St: St. Anthony Blvd. to 30th Ave. NE
- Coolidge St: St. Anthony Blvd. to 29th Ave. NE
- Anthony Lane: 29th Ave. NE to Cul-de-Sac

Removal and replacement of the existing asphalt trail and basketball court within Central Park and the installation of a pedestrian safety refuge at the intersection of Silver Lake Rd. and 34th Ave. NE are also being investigated with the improvements proposed for 2025.

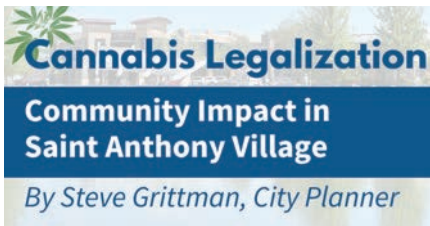

In Spring 2023, the Minnesota legislature passed legislation that has been prominent in the headlines since – the legalization of cannabis products for use, possession, and commerce. Most cannabis business regulation will be at the State level through the new Office of Cannabis Management (OCM). OCM will vet potential cannabis licensees, issue licenses, and manage the industry in Minnesota.

Licensing Review Process

The licensing review process is in progress, with certain locations beginning to pop up throughout the state. Minnesota's tribal governments were granted the ability to license their own industries. In those jurisdictions, business activities are well underway.

It's important to note that there are some key regulatory interactions that will impact St. Anthony Village. Some of those relate to local enforcement and compliance. Other aspects involve common land use regulations of "time, place, and manner."

There are 14 different kinds of business licenses that the State will grant to cannabis enterprises. Despite that daunting number, they break down into two general categories (at least for land use purposes): **Commercial Retail** uses, and **Industrial** (production, processing, and transportation) uses.

In St. Anthony, retail uses will primarily fall to the commercial zoning district (primarily in the St. Anthony Shopping Center area along Highway 88, and the Silver Lake Village shopping area along Silver Lake Road).

The legislation creates two general aspects of cannabis law – personal use and business activities.

Personal Use —

Individuals are allowed to use and possess cannabis products, although regulations continue to prohibit driving while under the influence, or possession in certain places, such as schools. The City of Saint Anthony Village recently created a provision that prohibits smoking (of any product) on public property, including parks.

Business Operations (two primary areas of local regulation) —

1) Number of Retail Licensees. The statute mandates that all local governments approve at least one retail location per 12,500 residents, although the community may authorize more if it wishes. At a population of about 10,000, St. Anthony will be required to approve one retailer. Just a note – this minimum standard is imposed whether or not the local community decides to create its own municipal dispensary operation.

2) Local Authority for Location. The new law permits the city to keep operations separate from certain types of land uses, including schools, parks with child-oriented facilities, child day care facilities, and residential treatment facilities. The limitation on this is that the city may not use these separation distances to effectively eliminate possible business locations. St. Anthony has created setback distance requirements for each in accordance with the law.

The St. Anthony Planning Commission and City Council will finalize its regulations around cannabis over the fall. It is expected that the Minnesota OCM will begin vetting license applications by early 2025 with business locations soon after.

Potter's Field.

"Lewis Stone deeded an acre of his land for the [St. Anthony] township cemetery in 1853." At that time, St. Anthony Township was part of Ramsey County and stretched west to the Mississippi River. "This 'potter's field' allowed burial places for even the penniless. Though the township charged \$1 for residents and \$5 for non-residents...people were known to have sneaked in at night to bury the dead."

Stone's wife was buried there but he and his family were not as they later left for Colorado. "No one has been buried there since 1940, and very few headstones (the [Alexander] McInnis's among them) stand out. On Stinson Boulevard between 29th and 30th Avenues, it's the oldest intact cemetery in Minnesota."

"In 1979, Girl Scout troop 1856, advised by Florence Marks and Sue Bailey uncovered this fact by piecing together maps and records. They arranged for the sculpture that stands there today titled 'Generation'".

The above story and "quotes" is from a press clipping found in our archives written by Penny Jacobson and Margo Ashmore and published in the Northeaster newspaper, Sept. 21, 1988. Our historical society retains the records of early township births, deaths, and burials.
