#### Summary Contains

42 year old male reported that someone entered the secured garage of his apartment building and stole his electric bike that had been locked to the storage rack. Security footage was received. Estimated loss value \$1,000. The serial number was received and entered into the computer.

RP reported his ex-girlfriend entered their apartment. He reported damage to property and several items taken. This case is pending further investigation.

28 year old male arrested and cited for driving after revocation.

Management reported a suspicious vehicle in the underground garage. The suspects were located and identified. A 25 year old female was arrested and booked at the Hennepin County Jail on two outstanding Hennepin County warrants for gross misdemeanor 5th degree possession of a controlled substance and misdemeanor 5th degree assault. Both the female and a 33 year old male were issued trespass notices from the location.

While speaking with a 22 year old female regarding an unrelaed incident, she disclosed that she had been physically assaulted by the suspect three month prior. She only wished the incident documented and didn't want another further police action.

24 year old male reported he lost is wallet after using the gym. He received an alert that one of his credit cards was used for a transaction at Walgreens in the amount of \$350. This case is pending further investigation.

A 24 year old male reported that he previously filed a theft report. He now reported that there was an attempted transaction on one of his credit cards in the amount of \$43.25. Security footage was reviewed and the suspect was identified as a 48 year old male. The suspect was located and booked at the Ramsey County Jail for felony financial transaction card fraud.

Officers received a report that an exterior window on the building was damaged. Photos were taken of the damage. Damage value undetermined at this time.

Employee reported a theft. The suspect was located and refused to identify himself to officers. The business did not wish to pursue charges. The suspect was verbally advised he was trespassed from the store.
