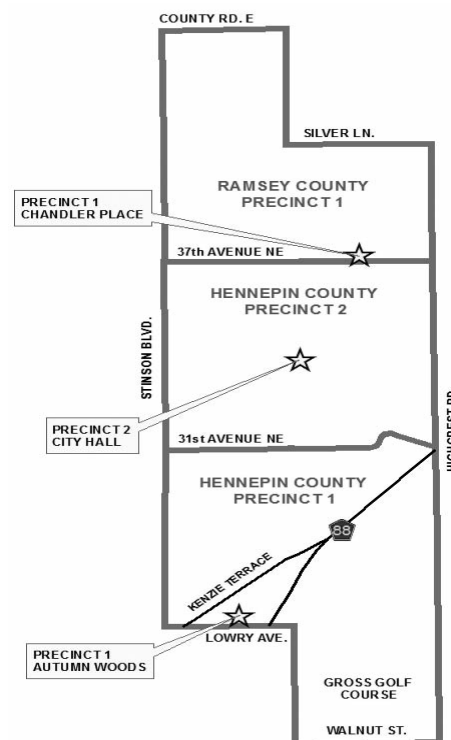

VOTER ELIGIBILITY

You may register to vote in Minnesota if you:

- * Will be at least 18 years old on Election Day and a citizen of the United States;
- * Will have resided in Minnesota for 20 days immediately preceding Election Day, and maintain residence at the address given on the registration form;
- * Have any felony conviction record discharged, expired, or completed;
- * Are not under court-ordered guardianship where a court has revoked your voting rights; and
- * Have not been ruled legally incompetent by a court of law.

REGISTERING TO VOTE

Unregistered residents are encouraged to pre-register to vote. Pre-registration must be completed at least 20 days prior to an election. Voter's registration applications are available on our website or at St. Anthony City Hall, 3301 Silver Lake Road. If you wait until election day to register, be sure to bring proper identification. Voters must provide a picture ID (a Minnesota driver's license or ID card) that shows their current address. If you have recently moved and your address has not been changed on your identification, you must correct it at a Department of Motor

Vehicles (DMV) office or bring along a utility bill due up to 30 days before or after election day that shows your name and current address in the precinct.

Utility bills include gas, electric, water, cable television, telephone, cell phone, solid waste, and sewer bills. You may also bring a registered voter from your voting precinct to vouch for you.

ABSENTEE VOTING

Residents who cannot vote in person during the election may vote by absentee ballot. Absentee ballot applications are available on our website, St. Anthony City Hall, or call 612-782-3313 to request one. Complete the application and return it to us as soon as possible so that we have plenty of time to mail the ballot to you. Absentee voting for the Primary Election will also be taking place at St. Anthony City Hall during office hours, Monday - Thursday 7:00 am to 4:30 pm and Friday 8:00 am to noon. Extended absentee voting hours for the Primary Election will be available on Saturday, August 11, from 10:00 am to 3:00 pm and on Monday August 13, from 7:00 am to 5:00 pm.

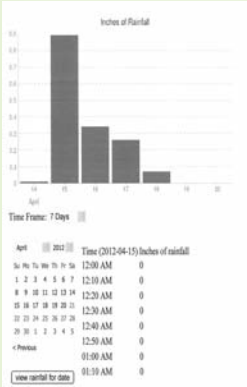

Water Quality Report 2011

The City of Saint Anthony Village is issuing the results of monitoring done on its drinking water for the period from January 1 to December 31, 2011. The purpose of this report is to advance consumers' understanding of drinking water and heighten awareness of the need to protect precious water resources.

We are committed to providing you with high quality drinking water.

St. Anthony's drinking water comes from two wells that draw water from the Jordan Aquifer. The wells are 541 and 472 feet deep.

The Minnesota Department of Health has determined that the sources used to supply your drinking water are not particularly susceptible to contamination. Drinking Water Regulations

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's safe Drinking Water Hotline (1-800-426-4791).

Water samples from the wells, the treatment plant, and from faucets throughout the community are tested to screen for contaminants so that harmful levels won't reach residents. Contaminants existing in the environment are divided into five basic testing groups and include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, can occur naturally or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides may come from sources such as agriculture, urban stormwater runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban stormwater runoff, and septic systems.

Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

The table listed on the next page shows substances that were detected in St. Anthony's drinking water during lab testing from January 1 to December 31, 2011.

No substances were detected at levels that exceed EPA or State guidelines.



Special Health Information

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline at (1-800-426-4791).

St Anthony Testing Results

No contaminants were detected at levels that violated federal drinking water standards. However some contaminants were detected in trace amounts that were within acceptable levels. The table above shows the contaminants that were detected in trace amounts last year. Some contaminants are sampled less frequently than once a year; as a result, not all contaminants were sampled for in 2011. These contaminants are listed in the table with the year they were last detected.

Terms to Know

The **Level Found** can be the highest amount found or the average of all samples analyzed, depending on how the regulation for the particular substance is enforced. If it is an average, it may be calculated with results from last year.

Regulated substances have **Maximum Contaminant Levels (MCLs)** set by the EPA. This is the highest level of the substance legally allowed in drinking water.

Some contaminants also have **MCL goals (MCLGs)**. This is the level of a substance where there is no known or expected health risk. MCLGs allow for a margin of safety. MCLs are set as close to MCLGs as feasible using the best available water treatment processes.

Some contaminants do not have Maximum Contaminant Levels established for them. These unregulated contaminants are assessed using state standards known as health risk limits to determine if they pose a threat to human health. If unacceptable levels of an unregulated contaminant are found, the response is the same as if an MCL has been exceeded; the water system must inform its customers and take other corrective actions.

MRDL-Maximum Residual Disinfectant Level.

MRDLG-Maximum Residual Disinfectant Level Goal.

AL-Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirement which a water system must follow.

90th Percentile Level-This is the value obtained after disregarding 10 percent of the samples taken that had the highest levels. For example, in a situation in which 10 samples were taken, the 90th percentile level is determined by disregarding the highest result, which represents 10 percent of the samples. In situations in which only 5 samples are taken, the average of the two with the highest levels is taken to determine the 90th percentile level.

ppm-Parts per million, which can also be expressed as milligrams per liter (mg/l).

ppb-Parts per billion, which can also be expressed as micrograms per liter (µg/l).

N/A-Not Applicable (does not apply).

Lead in Drinking Water

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of St Anthony is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing the tap for 30 seconds to 2 minutes before using water for drinking or cooking.

If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>

DID YOU KNOW.....The storage of refuse and recyclable collection items may not be kept in the front yard without approved screening or fencing. Once the trash has been picked up, please remember to remove your trash can and recycling bin from the curb and return them to the garage or some place out of site from the road. (Ord. 150.090)

DID YOU KNOW.....Parking in any residential district must be done on a surface paved with asphalt or bituminous material, concrete, cement, brick, or other paved surface. Parking vehicles on the grass is not allowed in the City of St. Anthony. (Ord. 152.179 subd. 3)

DID YOU KNOW....Any weeds or grasses, whether noxious as defined by law or not, growing outside the traveled portion of any city street or alley, or growing on private property, to a greater height than 6 inches or which have gone or are about to go to seed must be cut or removed by the owner of the property if the weeds are outside the right-of-way. (Ord. 94.32)

DID YOU KNOW.....Any vehicle without a current state registration must be parked in a garage or other building. If a vehicle has expired tabs, either renew them or move the vehicle into the garage. (Ord. 152.179 subd. 4)

DID YOU KNOW.....Travel trailers, campers, and other recreational vehicles may not be parked in any zoning district for use as a dwelling or for sleeping or house-keeping purposes. (Ord. 152.179 subd. 10)

DID YOU KNOW.....Before lighting a recreational fire, you must first call the St. Anthony Fire Department. You will receive a copy of the rules and review them with a member of the Fire Department. The Fire Department may prohibit any or all recreational fires when atmospheric conditions or local circumstances make such fires hazardous. Call 612-782-3400.

Please remember these ordinances have been put in place to keep St. Anthony clean, safe, and healthy. WHICH FIRE EXTINGUISHER IS RIGHT FOR YOUR HOME

Based on your home size, and the number of potential fire hazards, you should consider having one or more working extinguishers. You should also choose the extinguisher type that best fits your needs.

GENERALLY, THERE ARE THREE COMMON CLASSES OF HOME FIRE EXTINGUISHERS:

CLASS A - These are for wood and paper fires. This class cools material below its ignition temperature- and soaks fibers to prevent re-ignition.

CLASS B- These extinguishers suppress flammable-liquid and grease fires. They work by removing oxygen from the area sprayed and preventing vapors from reaching the ignition source. Chemical reactions that remove oxygen suffocate a fire.

CLASS C - These models are for electrical fires. They use an extinguishing agent that is not capable of conducting electricity.

MULTI-CLASS- These chemical extinguishers can be used on different types of fires and are labeled with more than one letter - A-B, B-C or A-B-C. (Note: Most multi-class extinguishers contain a corrosive agent that should be cleaned up immediately after use to prevent damage to sprayed surfaces).

P.A.S.S.:

- Pull the pin at the fire extinguisher top.
- Aim at the base of the fire.
- Squeeze the handle/lever to discharge.
(Stand back 6 to 8 feet from the flame.)
- Sweep the spray back and forth at the base or source of the fire



Home fire extinguishers, along with maintained smoke detectors, are important components of your home's fire defense system. Make certain all are working properly and maintained according to manufacturers' instructions.
