## *Notes from the Mayor*

Dear Residents,

It has been three years since we have added the word Sustainability to our mission statement. I cannot emphasize enough the power that one word has evoked in our conduct of city business.

When I speak with other city officials I always tell them of the accepting aspects of our residents in terms of embracing and implementing an idea and putting meat on the bone of this initiative. So what has occurred?

My first example would be that of the CFS (Citizens for Sustainability) in St. Anthony this is a quintessential grass roots effort that was spawned by concerned citizens that educate, advocate and motivate to create real world solutions for the average person to implement.

Organized Collection is a stellar illustration and a template of how we can be environmentally responsible, save money through garbage collection, decrease road wear, provide cleaner air, less noise, safer streets and not affect entrepreneurship. What a win for all! This is a model for any city to follow. Additionally, I would encourage all households to try using a small trash bucket and see if you can't recycle more and reduce your amount of throwaways. A smaller container is not only easier to move about but it is also cheaper.

Our third Sustainability Festival was conducted in November 2014 at Silverwood Park with the cities of Lauderdale, Falcon Heights, St. Anthony, CFS, U of M students, MWMO, RCWD and state agencies participating. I envision this to be the tipping point, as this was our largest attendance and I expect this to be an annual event and grow exponentially.

We have installed our Local Area Network (LAN) for the city's internal communications system thereby ensuring future resilience, capacity and cost control. Additionally St. Anthony has joined the Suburban Rate Authority (SRA) to monitor and intercede on behalf of cities' concerns as it pertains to the major utility service companies.

In health and safety we have enacted ordinances that control the use of e-cigarettes, equating it to that of tobacco products. By consolidating our records and placing them on Laserfiche we were able to free up space for our police department to have adequate area for locker rooms and a waiting location when officers must appear in court after their shift. Safe Routes to Schools brings us back to the option of children being able to walk safely to school. Through a collaboration of the federal and state governments, parents, school administrators and city staff we will be able to allow for the opportunity of our children to practice a healthier life style choice by walking to school.

Water enhancement projects this year include: Silver Lake carp removal, a Central Park biofiltration storm water treatment system and the Salo pond water treatment system.

And one last reminder is that you can recycle those old tangled Christmas light decorations in the Great Hall at the community center.

We cannot do any of this without the continued support and progressive spirit of you – the Villagers of St. Anthony – for that we are truly grateful. I look forward to another year of continued success with our partnership.

## ORGANIZED COLLECTION = CONSUMER PROTECTION

In September, the City Council approved a five year contract for organized solid waste and recycling collection that will begin on Wednesday, April 1, 2015. Initiating a plan for organized collection has been a long standing objective of the City Council and one of the city's goals for building and cultivating environmental responsibility. The three collectors (Walter's, Republic and Waste Management) will be assigned designated areas for collection proportionate to their current market share. Billing and customer service will remain the responsibility of the collectors. The city will ensure all provisions of the agreement are enforced. (Please see page 9 of VillageNotes for more information on organized collection.)

Along with lessening physical and environmental impacts such as road degradation and wear, organized collection also provides consumer protection for the residents of the City of St. Anthony. It is well-established and well-documented that rates charged for the collection of solid waste and related services in an "open hauling system," can vary from customer to customer. In organized collection, licensed collectors do not have the ability to raise rates over time and impose additional fees and surcharges beyond the negotiated base price for services. This includes a ban on add-on fees such as fuel surcharges, environmental fees and administrative fees. In addition, pricing will be both competitive and equitable.

We appreciate your patience during this time of transition.



## GENERAL ELECTION RECAP

The City of St. Anthony Village held the State General Election on Tuesday, November 4, 2014 and had a great turn out. The total number of voters was 4,125 or 68.33% of voters. This was well above the State of Minnesota's average of 51.3%.

This total number of voters of 4,125 is broken down between 3,530 in person on Election Day and 595 residents that took advantage of the no excuse absentee voting. The 595 absentee voters equates to a 9.9% absentee voter turn out. For a city our size, that is a large amount of absentee voters.



## 2015 STREET AND UTILITY RECONSTRUCTION

The 2015 Street and Utility Reconstruction will include 36th Avenue NE from Silver Lake Road to Highcrest Road, and Chelmsford Road from 36th Avenue to 37th Avenue NE. The project will include the replacement of the sanitary sewer, new water mains, and the complete reconstruction of these streets.



This year's project will also include the maintenance of St. Anthony Boulevard east of the Northeast Diagonal Trail and south to the City boundary near 35W. The existing pavement on St. Anthony Boulevard will be removed and a new asphalt surface placed on the roadway.

## WINTER WARNINGS

Oh the joys of winter! As Minnesotans, we are challenged to take on the responsibilities that winter blows our way. From traveling to shopping, we can't forget to do the "small things" that keep us safe. It seems like since the beginning of "Minnesota time", we have been living from forecast to forecast to see if we need to move our cars off the street to avoid that 2 inch snowfall ticket, or we need a discomforting sliding on black-ice, push your steering wheel through the dashboard, pucker-your-face kind of reminder to help us be more cautious as we drive on the ice rinks we call roads, during these frigid winter months.

Whatever snowbank gets in your way, the St. Anthony Police Department wants to help you and your family be as safe as possible during these cold winter months. Here are some tricks and tips to help keep you all warm inside this winter:

### Do NOT leave your car unattended when you are warming it up!

Instead, get a remote car starter. If that is not an option, dress accordingly and stay with your vehicle as it warms up. Car thieves are always looking for that person who leaves their car alone because they do not want to wait in the cold. Even locking your car, with the keys in the ignition to let it warm up is a bad idea. If your car is a target, it will just end up as a stolen car with a broken window.

### Attention to Snowbirds and WATCH for Snowbirds!

Are you going down south or vacationing somewhere warm this winter? For the migrating crowd, let someone that you trust know that you will be leaving and have them watch over your house. Ask them if they would be willing to shovel your sidewalks and entry ways too. This helps the caretaker see if there has been anybody walking up to your house if fresh snow falls and makes it look like the house is occupied. If you want, let our Police Department know the dates you will be gone and a house check form can be completed. Our Police Officers and Reserve Officers can check up on houses to make sure your house looks fine from the outside, while you are gone. 'Tis the season for two (2) inch SNOWFALL TICKETS! To avoid getting a ticket after a two (2) inch snowfall, watch the weather and play it safe! Check the St. Anthony City Website for the winter snowfall city ordinance for specific details (St. Anthony City Ordinance 72.36).

### Holiday Shoppers and Winter Drivers use extra caution!

For the holiday shoppers, watch out for the grinches that want to take your presents. Do not leave valuables or personal belongings in tempting locations. Also, keep track of your card and bank statements. Report any fraudulent transactions to your bank immediately and to the proper authorities where the transaction took place. As for winter driving, limit it during heavy or wet snowfalls. Decrease your speed when approaching an intersection because that is where black ice forms. Instead of that new 75" LED TV for a present, why not ask for some new tires if they are looking like NASCAR racing slicks? For your own safety, and the safety of others, make sure your vehicle is checked out to make sure it is winter ready.



## COLD WEATHER SAFETY

During the current cold Minnesota months, there can be many dangers associated with the dropping temperatures. We, at the St. Anthony Village Fire Department, want to make sure you are prepared for some of Mother Nature's hazards during the next few months. It is important to prepare for winter weather storms before they hit. This starts with having a plan with your family. Your family may not be together when disaster strikes, so it is important to know how you will contact one another, how you will get back together and what you will do in case of an emergency. Communication is a key component during a winter storm. Keep in contact with your friends and family so that they are aware of your whereabouts and safety.

One of the primary concerns is winter weather's ability to knock out heat, power and communication services to your home, sometimes for days at a time. One thing that is a good idea to have on hand at home is a weather radio. A weather radio broadcasts alerts and warnings directly from the National Weather Service for all weather related emergencies. Some cell phone providers even allow you to sign up in advance to receive notifications from local emergency services.

During storms and extreme cold, it is important that you stay indoors as much as possible. If you do have to venture out, make sure you are wearing proper warm clothes and that you are walking carefully on snowy and icy walkways. It is also important to be mindful of your health and the health of others:

- **Signs of Frostbite:** Occurs when the skin and body tissue just beneath it freezes. You can experience loss of feeling and white or pale appearance in extremities, such as fingers, toes, ear lobes, face, and the tip of the nose. **Seek medical help immediately!**
- **Signs of Hypothermia:** Dangerously low body temperature. Uncontrollable shivering, memory loss, disorientation, incoherence, slurred speech, drowsiness, and apparent exhaustion. **Seek medical help immediately!**

Cold weather can put an extra strain on the heart. If you have heart disease or high blood pressure, follow your Doctor's direction about shoveling snow or performing other work in the cold. If you have to do outdoor chores, don't forget to dress warmly and work slowly. Remember, your body is already working hard just to stay warm, so don't overdo it. Do not ignore shivering. It's an important first sign that the body is losing heat. Persistent shivering is a signal to return to the indoors.

Also, please keep in mind the elderly in our community. Check on your neighbors and assist them as they need. ## PROTECT YOUR WATER SERVICE FROM FREEZING

Due to the extreme frost conditions the metro area experienced last winter, there were many property owners in the area that experienced issues with frozen water line services. The City of St. Anthony wants to remind residents of this problem and provide advice on how to keep pipes from freezing. Thawing frozen service lines and plumbing can be costly to property owners.

Homes that use water less frequently are more susceptible to this problem. Empty and single-occupant homes are most at risk for frozen services. To avoid having a frozen service, residents can let cold water run from one faucet throughout the day and night. The amount of running water should be a little more than a trickle (the thickness of a pencil). The City of St. Anthony cannot credit you for the water that you run, but the associated utility charges could be less than the cost to repair or thaw your water service line.

You can measure the temperature of your water after running a faucet briefly until the water is cold. If you find it to be 35 degrees or colder, you should run water continuously to avoid a frozen water service.

### What to do if your pipes are frozen:

Contact City Hall at 612-782-3301. during normal business hours. After normal business hours contact the Fire Department at 612-782-3400.

Please note that the Minnesota Department of Health recommends that the thawing of service lines be done by a bonded plumbing contractor, certified pipe layer, or certified water operator. Minnesota Rules 4715 and 4720 prohibit connections between public water supplies and potential water contaminants, such as antifreeze.

City crews will be dispatched to evaluate the situation and assist the property owner. Remember, the property owner is responsible for maintaining water or sanitary sewer service from their building up to and including the connection to the main water or sewer lines.



## ST. ANTHONY SNOW REMOVAL AND PARKING REGULATIONS

During the winter, the number one priority of the Public Works Department is to clear the snow and make St. Anthony's streets safe for traffic and emergency vehicles. Here are a few reminders to assist residents in achieving this goal:



Residents are NOT allowed to park on ANY street for a period of 48 hours, after a two (2) inch continuous snowfall or until the snow removal has been completed from curb to curb.

The City understands that sometimes the schedule for snow removal doesn't correlate with residents' snow shoveling schedules. The snow plow drivers do their best to avoid pushing windrows of snow back onto freshly shoveled driveways or sidewalks.

Remember, it is dangerous for children to dig tunnels in the windrows of snow created by the snow plows. Tunnels can cave in, smothering the child. Plow drivers can't see children playing in or around the windrows and they can be covered or trapped in the snow.

Other ways to assist with snow removal operations include:

- Don't place refuse or recycling containers in the street; and
- Don't plow, blow or shovel snow into the street; and
- When shoveling, pile snow downstream of the plowing operations to minimize snow left in your driveway; and
- Stay back when driving behind plow trucks.




## VILLAGE IMPROVES QUALITY OF STORMWATER RUNOFF

In 2014, the City of St. Anthony Village undertook two large stormwater quality improvement projects. The first project is the Salo Ponds Improvement which removes soluble phosphorus, a nutrient necessary for algae growth, from stormwater prior to its discharge to Silver Lake. This project received significant funding assistance from the Minnesota Pollution Control Agency and the Rice Creek Watershed District.



In addition, the City recently completed a bio-filtration swale on the north end of Central Park to remove pollutants from stormwater discharged from our City to the downstream receiving waters in New Brighton at Pike Lake and Long Lake. This project received funding assistance from the Rice Creek Watershed District. Both projects meet the permit requirements of the Rice Creek Watershed District for the City's Street Reconstruction Program.



## THE IMPORTANCE OF PUBLIC ENGAGEMENT

A good planning process requires public engagement in order to develop community wide goals and to provide feedback on some specific types of projects before they are developed. One of the more traditional ways this is done is through the open public hearing. While most City actions do not legally require a public hearing, they are specifically required for many of the more common community planning and land use decisions. A formal public hearing is required by state law prior to the adoption of a City Comprehensive Plan (or amendment to), adoption or modification to Zoning Ordinance or Zoning Map, and prior to the issuance of a conditional use permit or variance.

When a public hearing is required prior to an action or decision, a notification is part of the requirements. These typically include newspaper legal ads and/or written letters to property owners adjacent or nearby development related projects. For some, speaking in public may be a bit intimidating. In these instances, we encourage you to submit written comments to the City Clerk prior to the meeting date, which will be accepted into the official record in the same manner as verbal comments.



The City of St. Anthony will continue its tradition of informal meetings for larger projects (i.e. street and utility construction/reconstruction projects, flooding related projects, or small area planning efforts). Informal meetings include public open houses, neighborhood meetings or similar casual opportunities for the public to learn about and provide feedback on a project or plan have become more common. It is imperative that interested individuals attend these, ask questions, and communicate concerns so that issues may be addressed at early stages of review. We encourage you to participate and give us your input!

### Take your old paint to your nearest paint store!

The PaintCare Minnesota program officially began November 1, 2014. In addition to the County's household hazardous waste drop-off sites that take paint products, there are now over 100 retailers that are accepting leftover paint for recycling. To find your closest location, go to [www.paintcare.org](http://www.paintcare.org) for a complete listing of businesses enrolled in this program. (Some restrictions apply, so residents and businesses are encouraged to call a site ahead of time to confirm what is accepted)

### Ramsey County Yard Waste Sites

The Ramsey County yard waste sites (except Arden Hills) will be open Saturdays (9 a.m. to 5 p.m.) and Sundays (11 a.m. to 5 p.m.) from December through March for yard waste and organics recycling. They will also take holiday trees, wreaths and garland (no lights, ribbon or wire.)

### Commercial Recycling Mandate

During the 2013-2014 Legislative session, commercial buildings recycling mandates were established. Effective January 1, 2016, new mandates require most businesses to recycle materials such as, but not limited to, paper, glass, plastic, and metal. ## UNWANTED MEDICATIONS from Rethink Recycling, Hennepin County and Ramsey County

### Reduction Tips

Reduce medicine and prescription drug waste whenever possible.

Use all antibiotics as prescribed by your doctor. Not using all doses of an antibiotic could lead to development of antibiotic resistant strains of bacteria.

For new medications, ask the doctor to prescribe only enough to see if the medication will work for you and in the lowest dose advisable. That way if the medication doesn't suit you, there is less to waste.

Buy only as much as you can reasonably use before the expiration date. Think twice before buying the bottle of 500 aspirin just because it's cheaper, unless you will use them all.
