COLLABORATIVE REFORM INITIATIVE

At the request of the City of St. Anthony, the United States Department of Justice (DOJ) has accepted us into the Office of Community Oriented Policing Services (COPS) Collaborative Reform Initiative for Technical Assistance (CRI-TA). CRI-TA is focused on helping cities find and implement ways to improve trust between law enforcement agencies and the communities they serve by providing a means to organizational transformation.

The CRI-TA uses assessment and technical assistance providers to coordinate the work through the involvement of subject matter experts, interviews, data and records analysis, research and analysis, and direct observations.

93% of the registered voters in St. Anthony participated in the election this year! That's up from 87% in 2012.




New this year was no excuse absentee voting.

1 out of 5 people who voted in St. Anthony voted absentee!



CITY RECEIVES \$10,565,371 FROM UNITED STATES ARMY

We are excited to announce the City of St. Anthony has received \$10,565,371 from the United States Army for the construction of the Advance Oxidation Process (AOP) expansion to the water treatment plant. Construction has already begun and we anticipate the AOP to be fully on-line and operational by August.



To retrace this past year, in February 2015 the contaminant 1,4 – dioxane was discovered in the same aquifer that our drinking water comes from. Immediately, the City of St. Anthony began testing our wells and, throughout this entire time, the City of St. Anthony's drinking water has not exceeded the 1 part per billion health advisory level established by the Minnesota Department of Health (MDH). A thorough explanation is available in the Spring 2016 city newsletter still available on the city website, with additional updates in subsequent newsletters and postings. A fast track approach was arrived at early in the process due to the cooperative spirit adopted by both the United States Army and the city leadership.

With a dedicated team of staff under guidance from the Mayor & Council, the AOP solution was deemed to be the most cost effective and environmentally conscious alternative. The \$10,565,371 includes:

- Construction of the AOP plant addition
- Allowances for contingencies and ancillary equipment needed
- Modifications to existing system for blending from multiple wells
- Refunding of lost revenues due to water restrictions
- Compensation for temporary closures of splash pads
- Relocation costs for half-court basketball facility
- Reimbursement for legal, engineering and staff time.

The AOP expansion provides assurances to residents that the City of St. Anthony will continue to deliver safe and reliable drinking water. Furthermore, through this process, the City of St. Anthony continues to be a leader in environmental sustainability by removing a contaminant from an aquifer that stretches far beyond our city limits. As the recipient of the League of Minnesota Cities' City of Excellence Sustainable City Award, we again demonstrate our commitment to local action for a greater good.

THE PROBLEM WITH PAINT

Unwanted paint can be a problem. Leftover liquid paint doesn't belong in the trash. Both oil and latex paints need to be disposed of properly. When discarded in the trash, the paint creates problems for waste collectors and for facilities that process our garbage.

Oil-Based Paint

Oil-based paint contains hazardous ingredients. Do not put it in the trash and do not mix it with latex paint.

Take leftover oil-based paint to your county household hazardous waste (HHW) drop-off site.



Latex Paint

The best option is to use your leftover paint, or find someone who can. If you can't use it up, you can bring in your latex paint to your county's HHW drop-off site to be recycled. If you have a small amount of latex paint that has completely dried out, you can place it in the trash with the lid off.

Take leftover oil-based paint and liquid latex paint to your county HHW drop-off site. Visit RethinkRecycling.com/hhw to find your county's HHW drop-off site.

2017 Street and Utility Improvement Project


The 2017 Street and Utility Improvement Project consists of complete street and utility reconstruction along the following roadways (illustrated below):

- Penrod Lane from 36th Avenue NE to Skycroft Drive NE
- Skycroft Drive from Penrod Lane to Maplewood Drive
- Chelmsford Road from 36th Avenue NE to Maplewood Drive
- Maplewood Drive from Skycroft Drive to Highcrest Road (including cul-de-sacs to the north)



Advanced Oxidation Process Water Treatment Plant

The addition to the water treatment plant was designed in early 2016, with bids received in August of 2016. The contract was awarded to Gridor Construction, Inc. of Buffalo, MN, and construction began in September of 2016. The Contractor has completed installation of the foundation and walls of the building, including masonry, plumbing, and electrical. The Contractor is anticipated to continue construction of the new building throughout the spring with completion anticipated in late summer of 2017.



Highway Safety Improvement Program (HSIP) Project


Bids were received on September 15, 2016. Bids received were higher than anticipated and the project was NOT awarded by the City Council. The project is proposed to be re-bid in January of 2017.

Sidewalk improvements along Stinson Boulevard, originally proposed to be included with the HSIP project, were solicited to contractors and awarded to Concrete Idea, Inc. The sidewalk along Stinson Boulevard was installed this past fall to coincide with the completion of the 2016 Street and Utility Improvement Project.



Also, proposed for improvement in 2017 is the bituminous mill and overlay along Silver Lake Court from Silver Lane to the cul-de-sac (illustrated below).

The projects are currently out for bid with the project anticipated to be awarded to the lowest responsive and responsible bidder in late February of 2017.

Mirror Lake Water Quality and Flood Mitigation Improvement Project

The contractor has dewatered the lake and has completed the storm sewer installation. Once the lake bottom freezes the contractor will begin the tree removal and excavation of the nutrient rich soils. Final shoreline restoration will occur in the spring of 2017 along with the installation of the outlet control structure.

ILLICIT DISCHARGE FACT SHEET

Have you ever seen your neighbor blowing leaves or lawn clippings into the street? Or how about seeing someone dumping paint or used oil into the storm drain? Have you ever seen any murky water running down the ditch? What we do at home affects our local water resources because our storm drains and ditches are connected to nearby lakes, rivers, and streams. Remember, **only rain down the drain.** Below are examples of illicit discharges. If discovered, please contact the City at (612) 782-3301.

As an MS4 (Municipal Separate Storm Sewer System) community, St. Anthony regulates non-stormwater discharges to the storm drainage system. The City's Code Chapter 50: Storm Water and Sanitary Sewers, Section 50.30 – Illicit Discharge and Connection contains enforcement actions the City can take in the event an illicit discharge occurs.

Sources of Illicit Discharge:

- Sanitary wastewater
- Sediment from construction site runoff
- Landscape waste
- Paints, solvents
- Used oil, radiator flushing, grease
- Cleaning products
- Spills from accidents
- Improper disposal of household toxics
- Laundry wastewaters
- Illegal connections to the storm sewer system
- Commercial car wash wastewater





WINTER PARKING AND SNOW PLOWING

D

uring the winter, the number one priority of the Public Works Department is to clear the snow and make St. Anthony's streets safe for traffic and emergency vehicles. Here are a few reminders to assist residents in achieving this goal:

Residents are NOT allowed to park on ANY street for a period of 48 hours, beginning immediately after two (2) inches or more of continuous snow fall or until the snow removal has been completed from curb to curb.

The City understands that sometimes the schedule for snow removal doesn't correlate with residents' snow shoveling schedules. The snow plow drivers do their best to avoid pushing windrows of snow back onto freshly shoveled driveways or sidewalks.

Remember it is dangerous for children to dig tunnels in the windrows of snow created by the snow plows. Tunnels can cave in, smothering the child. Plow drivers can't see children playing in or around the windrows and they can be covered or trapped in the snow.

Other ways to assist with snow removal operations include:

- *Don't place refuse or recycling containers in the street; and
- *Don't plow, blow or shovel snow into the street; and
- *When shoveling, pile snow downstream of the plowing operations to minimize snow left in your driveway; and
- *Stay back when driving behind plow trucks.

With your cooperation, snow removal can be more efficient and roads cleared in very little time. CARBON MONOXIDE AND YOUR HOME

Carbon Monoxide (CO) is often referred to as the “invisible killer” due to the poisonous gas being colorless and odorless. CO is the product of incomplete combustion. Appliances in the home such as gas furnaces, stove ranges, dryers and fire places, are all sources of CO. CO is released when these appliances malfunction or are improperly installed. More than 400 Americans die each year from unintentional CO poisoning. With thousands more hospitalized, these are statistics that can be prevented.

CO in the body produces flu-like symptoms due to the carbon monoxide inhibiting the blood's ability to carry oxygen throughout your body. Initial symptoms can include dizziness, severe headache, nausea, fatigue

and confusion. In extreme exposure, unconsciousness, brain damage, heart failure, lung failure, and sometimes death.

The first step you can take to keep you and your family safe is by installing Carbon Monoxide detectors on every level of your home, especially near sleeping areas. The only way to detect CO in your home is with a CO detector. Never leave your car idling in a closed garage or use fuel-powered appliances and/or tools in an area with poor ventilation. Lastly, with the winter months upon us never use a gas range/stove to heat your home!



ACRONYMS, TAG-LINES, CATCHWORDSWHAT DO THEY ALL MEAN?

After recently participating in a conference call regarding a software upgrade, I was left wondering how many three-four letter acronyms exist in the IT environment! Upon reflection, I thought the same could be said about the language used when discussing City Finances. The certain phrases and key words that have significant meaning within City Hall may fall flat Citywide. Therefore, I have highlighted below certain terms often used by City Finance and their meaning in terms of impact to City residents and businesses.

- Sustainability – The continued ability to provide City Services at the level residents and businesses are accustomed.
- Structurally Balanced – Revenues and fees are set at rates necessary to meet the annual cost of the service provided. Using this approach provides for reasonable year to year adjustments in rates. Thus, providing a degree of predictability for residents and businesses as to the costs paid for city services and avoiding spikes in rate adjustments.
- Fund Balance Policy – Retaining sufficient cash holdings to meet day to day operating needs. The City's core operating funds receive tax collections in July and December. Therefore the cash on hand at year end along with subsequent revenues are projected annually as to ensure timely payments of City obligations.

AVOIDING TAX-RELATED IDENTITY THEFT

Winter is upon us. A new year is upon us. Tax season is upon us. And with that, we'll all need to do what we can to protect ourselves from tax fraud and identity thieves. It's a scary thing. But, the IRS provides resources and references to help you protect your tax-related identity information. Many of these are simple tips we can easily do ourselves which will make it harder for scammers, hackers and thieves to steal our sensitive information. You can find all of this information on the IRS website, www.irs.gov, and simply searching the site for "tax security".

The IRS recommends the following steps to protect from becoming a tax related identity theft victim:

- Use security software and keep it up to date
 - The software should include virus and malware protection
 - File encryption capability
 - Firewall
- Use strong passwords (10 to 12 characters that include numbers and symbols)
- Only send personal information over encrypted/secure websites – check for "https" in the web address
- Back up your computer files on a removable disk or hard drive
- Research companies to determine who you're really dealing with online
- Do not leave personal information lying around or up on a computer screen

Beware of phishing emails, phone calls, or texts that appear to be from the IRS, or financial institutions you might be familiar with and normally trust. Go directly to the company's website to check for legitimate information. Don't click on links from suspicious or unknown emails, or download attachments if you don't know who sent it or aren't sure of what it is. Do not install or download software unless it's from a company or website you trust and are familiar with. Use a pop-up blocker on your web browser.

Don't fall victim to IRS impersonators. The IRS does not call taxpayers and threaten lawsuits, arrest, or jail. The IRS also does not send unsolicited email requesting that you update your account, provide sensitive personal or financial information online, or to inform you of a refund. The IRS does not initiate contact through text message or social media. These are all indications of scams. Report IRS scam emails to phishing@irs.gov, and IRS impersonation phone calls as www.tigta.gov (I've visited this website, which takes you to the Treasury Inspector General for Tax Administration web site). There is an IRS impersonation scan reporting link on the upper right side of the web page.

The IRS suggests annually checking your Social Security Administration records by signing up for My Social Security at www.ssa.gov. The IRS also reminds us to check your credit report annually and to regularly check bank and credit card statements. If you are a victim of tax related identity theft, please go to www.irs.gov/identitytheft for what to do next.

COMPREHENSIVE PLAN PROCESS CONTINUES

The City is in the middle of updating the Comprehensive Plan that guides city policy related to land use and infrastructure through the year 2040. State Statute requires that every city in the seven county Twin Cities metropolitan area update their plan by the end of 2018. This process is a chance to engage with residents, businesses, and Planning Commission/City Council in the vision for the next 25 years for growth, stability, infrastructure, and housing in the community. City staff undertook a large community visioning effort earlier in 2016, and received great feedback on the priorities of the community. Top priorities include: making the city more walk and bicycle friendly, continuing to be leaders in sustainability efforts around energy and

water, examining future re-uses for the Walmart site and former bowling alley site, encouraging a multi-generational community, and maintaining and increasing the supply of affordable housing. Currently, the city is undertaking the infrastructure analysis related to sewer, water, and transportation as required by the Metropolitan Council. The City will be finishing the Comprehensive Plan in the summer and fall of 2017.

PLANNING COMMISSION

The Planning Commission is a seven-person body meeting the fourth Monday evening of each month at 7PM in the City Council Chambers. Typical agenda items include: land use and development, city ordinance modifications and variance requests made by both residents and businesses. While regular Planning Commission meetings during 2016 were comprised primarily of the more routine

matters, members attended "work sessions" dedicated to development of the Comprehensive Plan which on occasion featured community development consultants. Members also participated in citizen engagement meetings where a variety of topics essential to city residents were identified, discussed and incorporated into the Comprehensive Plan. There was not a scheduled meeting this past December, but after the first of 2017 efforts will refocus on completion of the Comprehensive Plan and begin review of proposed redevelopment of the Lowry Grove property.

PARKS COMMISSION

The Saint Anthony Parks Commission is a 5 member advisory commission appointed by the City Council. In 2016 the commission expanded it's work to include sustainability initiatives such as becoming a Tree City USA. In 2017 we plan to continue that work which will include:

- Continue and expand sustainability initiatives such as the rain barrel workshop and pollinator gardens.
- Explore pedestrian and bike friendly routes.
- Assess pocket parks for potential added amenities.
- Partner with schools and Rice Creek and Mississippi Watershed Management Organizations to create water conservation

education and initiatives. We will also be looking at ways to continually improve our current parks.
