## A Note from the Mayor.....

I would like to highlight what is the most important function that city government provides to its citizens and that is infrastructure. It is defined in the dictionary as "the underlying foundation or basic framework (as of a system or organization)." That too would imply both the physical infrastructure i.e. water plant, sewers, roads, bridges, parks, equipment, buildings but also the social infrastructure i.e. police department, fire department, churches, schools, Kiwanis's, Sister City Association, Vital Aging Council, and Chamber of Commerce to name a few, all are integral components of the total infrastructure.

Infrastructure is an important part of our daily lives. If we short change it or ignore it will eventually come back to haunt us. The old adage is "you can pay now or pay later" and later is almost always more costly. That is why we in St Anthony take such a proactive role in ensuring that clean safe water enters your home and waste water is efficiently removed and treated, that roads are swept, plowed and maintained, that city departments (fire, police, public works) are adequately equipped and staffed. However none of this could happen without the support of the residents, council, staff and consultants. When individuals work to make things better by being involved we can see the continued excellent results that this community produces. Again I cannot emphasize enough or thank you enough for your commitment and continued support to our treasured city.

Let me update on a number of our 2007 goals. The sidewalks and streets lights have been completed along the east of the city from 37th Avenue to 29th Avenue. The Silver Lake Road improvement project is underway with the underlayment of overhead power and utility services with the road work to begin in the spring of 2008. We are working on environmental priorities that reduce the use of resources and improve efficiency and will provide cost savings throughout city facilities. The city's ordinance are being updated and codified to reflect the changing environment and court decisions. We have completed our financial management planning that looks 5 to 10 years in the future with an emphasis on the next 5 years. This allows us to plan for the future rather than react to the latest crisis. The bottom line is that the city is in great financial position now and for the foreseeable future. However we will continue to plan and look for initiatives and opportunities to enhance and improve our quality of life in St Anthony!

I would also encourage everyone to validate our most precious freedom and vote on November 6th, please see the enclosed article for polling locations and times. As this is our last newsletter for this year - on behalf of the city council and staff we wish you and yours a happy holiday season.

## **2007 Street Reconstruction Project**

The 2007 Street reconstruction project is nearing completion. Curb and gutter was installed on all city streets during September. Alley work and restoration of driveways will continue through September.

### **Foss Road Lift Station**

Construction of the lift station began the week of August 13th.

### **Silver Lake Road**

The first round of tree removal along the west side of Silver Lake Road has been completed. Comcast has been installing their utilities under the proposed new curb line of Silver Lake Road. They are anticipating the work could take up to 2 ½ months to complete.



Xcel Energy and Centerpoint Energy began relocation of gas mains and overhead power lines to underground in September. We are anticipating that most of this utility work will be completed using directional boring techniques, causing minimal disturbances along the corridor. There will however, be locations where transformers, distribution hubs, and handholds will need to be located to provide service to the adjacent residents and to provide access for maintenance. The utility companies will restore the areas disturbed to a minimal level.

Because the utility work is scheduled to be completed this year, Hennepin County anticipates that street construction in 2008 can proceed in a timely fashion with limited delays associated with utility conflicts.

Hennepin County has been in the process of acquiring easements and rights-of-way necessary to facilitate the construction and improvements of Silver Lake Road. Construction is scheduled to begin in April or May of 2008.

### **Automatic Water Meter and I & I Inspection Program**

To date, there remains less than 50 meters to be installed within the City. Approximately 800 meters need to be reprogrammed to communicate with new receivers being installed on public buildings. This reprogramming process will take a few minutes and will be completed by appointments.

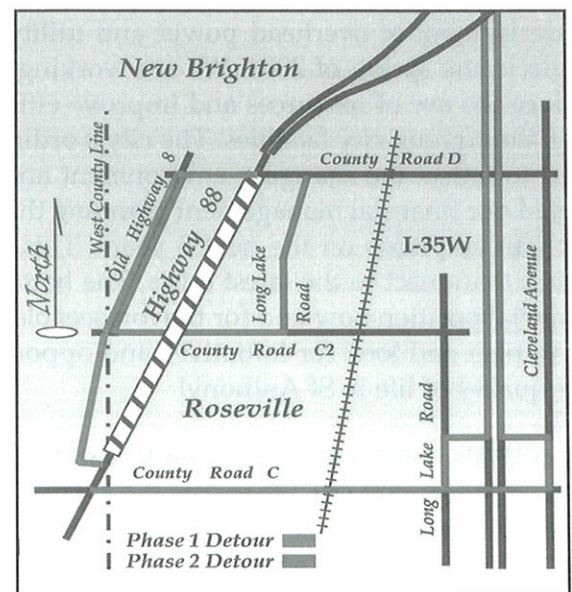
The City has prepared a report and sent it to the Metropolitan Council updating them on the status of the number of passive drain tile systems discovered and removed from the sanitary sewer system to date.

### **Highway 88 Resurfacing**

Ramsey County Public Works began reconstruction of Highway 88 from County Road C/29th Avenue to County Road D/37th Avenue. This reconstruction consists of resurfacing the highway with bituminous materials.

The project will be completed in two phases. Phase I will close Highway 88 from West County line to County Road D in mid September. Phase II will close County Road D for an additional one week, but during Phase II County Road C2 will be open. There have been detours prepared during this reconstruction period.

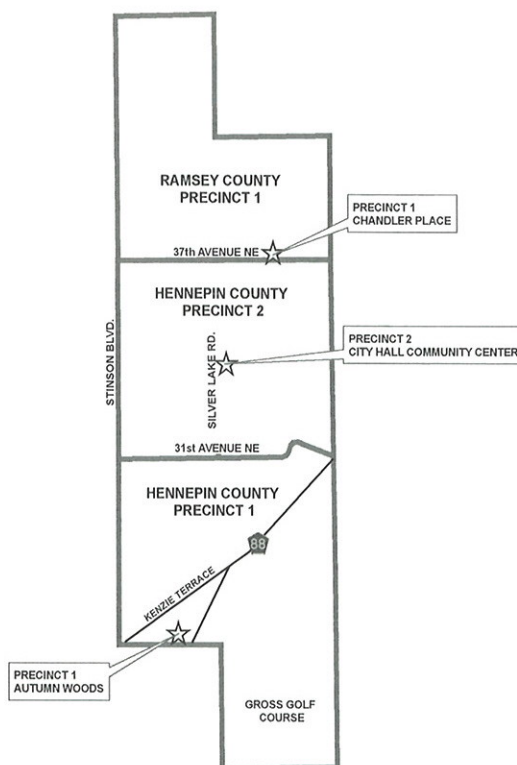

## City Commission Seat Opportunities

The City of St. Anthony will have two seats available on the Planning Commission beginning January 1, 2008. The Planning Commission is a paid per month governing body, which makes recommendations to the City Council on planning issues such as variances, conditional use requests, zoning issues, etc. The Commission meets on the third Tuesday of every month at 7 p.m. at St. Anthony City Hall. Applications are being accepted until November 16, 2007.

The Parks Commission has three seats available. This is a volunteer group which advises the City Council regarding the promotion of the systematic, comprehensive, and effective development of park facilities necessary for the overall health, ability, and well being of city residents of all ages. ## HOUSING CODE CORNER

**DID YOU KNOW**.....The storage of refuse and recyclable collection items may not be kept in the front yard. On trash pick-up day, please remember to remove your trash can and recycling bin from the curb and return it to the garage or some place out of site from the road.

**DID YOU KNOW**.....Parking in any residential district must be done on a surface paved with asphalt or bituminous material, concrete, cement, brick, or other paved surface. Please remember parking vehicles on the grass is not allowed in the City of St. Anthony.

**DID YOU KNOW**.....Any vehicle without a current state registration must be parked in a garage or other building. If a vehicle has expired tabs, either renew them or move the vehicle into the garage.

**DID YOU KNOW**.....The owner and occupant of property adjacent to a public sidewalk must use due diligence to keep the walk safe for pedestrians. All ice and snow must be removed within 12 hours after it has deposited.

**DID YOU KNOW**.....Before residents can have a recreational fire you must first call the St. Anthony Fire Department. You will receive a copy of the rules and review them with a member of the Fire Department. The fire department may prohibit any or all recreational fires when atmospheric conditions or local circumstances make such fires hazardous. Call 612.782-3400.

Please remember these ordinances have been put in place to keep St. Anthony clean, safe, and healthy. ## National Night Out 2007

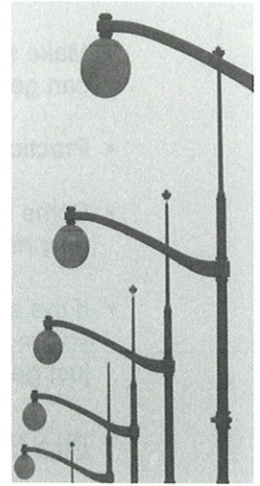

## St. Anthony Fire Department Reminds St. Anthony Residents to “Practice Your Escape Plan”

The St. Anthony Fire Department is joining forces with the nonprofit National Fire Protection Association (NFPA) to remind local residents to 'Practice Your Escape Plan.' During this year's fire safety campaign, firefighters and safety advocates will be spreading the word about the dangers of home fires and teaching local residents how to plan and practice escape from a home in case a fire occurs.

According to the latest NFPA research, 3,030 people died in 2005 in home fires – that's roughly eight people every day. Being alerted to a fire and knowing what to do to escape from one are extremely important, yet only 23% of households have planned and practiced a home fire escape plan.

"Many times when we speak to residents who have experienced a fire in their home, they recall becoming confused and disoriented by the conditions and severity of the situation – but they realized they needed to get out fast," said Fire Chief John Malenick. "Sometimes there are only seconds to escape, but there's no question that having a plan in place that has been practiced saves precious time and makes survival more likely. We hope that Fire Prevention Week will prompt folks in our community to plan and practice their escape."

Are you prepared for a fire? Although it's difficult to prepare for the unexpected, reviewing the information below and taking action based on it to plan for a fire is strongly recommended... and don't forget to practice your escape plan during Fire Prevention Week!

- Install working smoke alarms on every level; and inside and outside of each sleeping area.
- Develop a fire escape plan that identifies two ways out of each room and a family meeting place outside.
- Make sure your plan allows for any specific needs in your household. If everyone knows what to do, everyone can get out quickly.
- Practice using the plan, at least twice a year.
- Some studies have shown that some children and adults may not awaken to the sound of a smoke alarm; they may need help waking up.
- If the smoke alarm sounds: Go to your closest exit, and if you run into smoke, turn and use another way out. If you must exit through smoke, get low and go under the smoke to your exit. Don't take time to pick up belongs; just get out and help others get out. Move fast but stay calm.

It's a problem often faced by firefighters, paramedics and police officers while en route to an emergency. Drivers who are not aware of the approaching emergency vehicle until the last moment. First they panic, hit the brakes, and then stop in the middle of the road. Emergency personnel anticipate this possibility, and can usually steer around the vehicle as so not to waste valuable seconds.

We experience this more frequently then you might think. However, we understand why it happens and that is why we are trained on how to deal with it. But even with our training and the understanding that comes with it, we still feel it is important to provide a refresher to those in the community that we serve.

Emergency personnel understand the sudden surprise that motorists normally experience at the sound and sight of an emergency vehicle rapidly approaching. But it's important to think ahead. Train yourself to instinctively pull to the right at the sound/sight of emergency vehicles, just as you automatically slow and stop for school buses when their yellow and red lights begin flashing. If you notice other vehicles around you pulling to the right but are unsure why, slow down and look around. If you see or hear an emergency vehicle, move to the right and stop.

The following are some do's and don'ts that we as emergency responders would like you know.

### DO'S

- Remain Calm! Don't Panic.
- Pull to the right and come to a stop.
- When on a high-speed road or when there is no room to stop, slow down as much as possible.
- When in the left lane, pull over into the right lane as traffic in the lane to your right allows.
- If you cannot move to the right because of an obstacle, such as a car to your right, simply stop. Your prompt action will let the driver of the emergency vehicle know what you are doing; it will allow the driver to anticipate where to drive.
- When an emergency vehicle approaches you from behind while you are stationary at an intersection stop sign or red light, DO NOT move unless you can pull to the right.
- On a 4-lane highway or street without barriers, both sides of traffic should pull to the right. (The emergency vehicle may have to turn in front of oncoming traffic.)

### DON'TS

- Don't stop in the middle lane when there is room to pull to the right.
- Don't pull to the left in the center lane or left turn lane.
- Don't drive through a red light or stop sign when an emergency vehicle approaches from behind.
- Don't turn quickly to the left into a driveway or street.
- Don't race ahead to get through a green light or turn before the emergency vehicle gets there.
- Don't disregard the presence of the emergency vehicle by continuing to drive.

We also ask that in order to hear the siren you keep your radio volume down and limit your cell phone use. It's those valuable seconds saved that truly can make a difference.



## Improving Water Quality

As autumn approaches and the leaves fall from the trees, please help to ensure that they do not end up in streets or gutters. When you rake leaves, keep them in your yard and bag them as soon as possible so that the wind cannot blow them into the street. Leaves in the street end up in the storm sewer system, which eventually carries them to lakes and streams where they degrade water quality. Thank you for helping to improve the quality of our natural resources.

## Sewer and Water Emergencies

If you have a sewer or water emergency, call city hall immediately at 612-782-3301 during normal business hours. For after hours service contact the fire department at 612-782-3400. City crews will be dispatched to assess the situation and assist the property owner in taking care of the situation. Remember, the property owner is responsible for maintaining water or sanitary sewer service from their building up to and including the connection to the main water or sewer lines.

## Adopt a Fire Hydrant

The fire department would appreciate residents' help in keeping the snow cleared away from pathways and fire hydrants. The accumulation of excess snow blocks the view of responding fire apparatus's to fire hydrant locations. Precious time is wasted when firefighters have to look for and uncovering fire hydrants. Please help by occasionally shoveling around fire hydrants, keeping them accessible in case of a fire.



## Fire Hydrant Flushing

Fire hydrant flushing will occur October 24 - 26 between midnight and 7 a.m. to minimize inconvenience to residents. Flushing of the hydrants is done for the following three reasons:

- \* to make sure hydrants are in good working condition; and
- \* to flush out sediment and rust deposits that accumulate in the water systems; and
- \* to evaluate water pressure throughout the City.

This exercise is very important for the well being of the water system. Thank you for your cooperation.



# About Snow Plowing

The City's snow plowing crews' number one priority is to clear snow away to make the streets safe for traffic and emergency vehicles. Sometimes the crews' schedule for plowing does not coincide with residents' snow shoveling schedules. Please keep in mind the crews do not intentionally plow windrows of snow back onto freshly shoveled driveways or sidewalks.

Also, it is dangerous for children to dig tunnels in these windrows created by the snowplows. Tunnels can cave in, smothering the children. Plow drivers also cannot see children playing in or around the windrow. Children can be covered and trapped by these snow plow windrows.

Other ways to assist with snow removal operations include:

- \* Do not place refuse or recycling containers in the street;
- \* Do not plow, blow or shovel snow into the street;
- \* Pile snow downstream of the plowing operation to minimize snow left in your driveway from the plow;
- \* Stay back when driving behind plow trucks.

At our June 18th, 2007 meeting many of the board members began talking about remembrances of places and people they once knew from the Village. It was quite an enjoyable session as many found themselves remembering some of the same things. Do you remember any of these places or people? Do you have any other remembrances to contribute? The Village Shopping Center from the 1950's - approximately:

McPherson's 3 Circle Drive In was across from WIN's Drive-In that became Mr. Hobo.

There were two Snyder's stores in the Shopping Center: Snyder Brothers and Snyder's Rexall

Sears, Perkins, Crown Auto, Schwinn Bikes, Red Owl, JC Penney, Warner's Hardware, and Cake n' Steak were there as well.

Some folks remember that Ed and Catherine Szurek owned a business but couldn't remember what it was.

The Shopping Center was the site of early VillageFest celebrations. Bill Sauer remembers dropping the first Ping-Pong balls from a helicopter there in 1968 or 1967.

### **SAV High School Band**

Roger Bjorkland, the director, was a strong force in developing and maintaining a strong band program starting in the 1960's. He did not have both a school orchestra and a band because in a small school there would be a limited number of good musicians. So he put them all in the band.

Charles Kirk recollected one account of a band trip to New York and side trip to Atlantic City with Dr. Carr and Bob Ernt as chaperones. After the group had visited the Statue of Liberty, the head count was short one student. As the rest of the group went on to Atlantic City, Bill Carr and Bob Ernt went to look for the student in New York City. When the band arrived in Atlantic City, the missing student was already there. He had decided to hitchhike there on his own. Mr. Bjorkland called the student's parents to have them meet their child at the Mpls/St.Paul airport and put the student on the next plane home.
