### *Note from the Mayor*

Dear Residents,





## VOTER ELIGIBILITY

You may register to vote in Minnesota if you:

- \* Will be at least 18 years old on Election Day and a citizen of the United States;
- \* Will have resided in Minnesota for 20 days immediately preceding Election Day, and maintain residence at the address given on the registration form;
- \* Have any felony conviction record discharged, expired, or completed;
- \* Are not under court-ordered guardianship where a court has revoked your voting rights; and
- \* Have not been ruled legally incompetent by a court of law.

Vehicles (DMV) office or bring along a utility bill due up to 30 days before or after election day that shows your name and current address in the precinct.

Utility bills include gas, electric, water, cable television, telephone, cell phone, solid waste, and sewer bills. You may also bring a registered voter from your voting precinct to vouch for you.

## ABSENTEE VOTING

Residents who cannot vote in person during the election may vote by absentee ballot. Absentee ballot applications are available on our website, St. Anthony City Hall, or call 612-782-3313 to have one mailed out. Complete the application and return it to us as soon as possible so that we have plenty of time to mail the ballot to you. You can also absentee vote at St. Anthony City Hall during office hours, Monday - Friday 8:00 a.m. to 4:30 p.m. Extended absentee voting hours for the election will be available on Saturday, November 3, from 10:00 a.m. to 3:00 pm and on Monday, November 5, from 8:00 a.m. to 5:00 p.m.

## REGISTERING TO VOTE

Unregistered residents are encouraged to pre-register to vote. Pre-registration must be completed at least 20 days prior to an election. Voter's registration applications are available on our website or at St. Anthony City Hall, 3301 Silver Lake Road. If you wait until election day to register, be sure to bring proper identification. Voters must provide a picture ID (a Minnesota driver's license or ID card) that shows their current address. If you have recently moved and your address has not been changed on your identification, you must correct it at a Department of Motor

## COLLABORATE TO GROW SUSTAINABILITY EFFORTS

Mayors Jeffrey Dains of Lauderdale, Peter Lindstrom of Falcon Heights, and Jerry Faust of St. Anthony Village are convening their residents this fall to collaborate on making their communities more sustainable. This effort will be led and facilitated by University of Minnesota students and instructors as part of coursework related to the Sustainability Minor program. The workshops will be held on **October 11th** and **November 1st** from 6:00 p.m. - 9:00 p.m. at Silverwood Park's Great Hall [www.threeriversparks.org/parks/silverwood-park.aspx](http://www.threeriversparks.org/parks/silverwood-park.aspx) in St. Anthony Village. All residents are welcome and encouraged to attend.

"It is important that all communities continue to steadfastly push the bar in making sustainable living and development a higher priority. The next generations are counting on us and we want to make sure we are doing our part and doing it effectively," noted Mayor Dains.

The October sustainability workshop will focus on developing a shared understanding of scientifically-based sustainability principles and a vision to guide the effort forward. The November workshop will focus on development of specific strategies. After the two workshops are completed, a report will be completed for each community to document outcomes from the conversation and recommend next steps.

Mayor Lindstrom highlighted the importance of this work pointing out that, "Our short-and long-term health and well-being are directly tied to how smart we are about building and maintaining our communities and carrying it out in our daily lives. We know there's still plenty of room in our communities to be more strategic and efficient with the resources we use in all our systems - from food and water to transportation to buildings to energy. We want this effort to be jointly held by residents and their local governments and want to partner with our neighboring cities so we can be more effective and have a greater impact. We all matter and can have an impact when it comes to making our lives more sustainable."

Mayor Faust stated, "We are excited about the opportunity to strengthen the link between the University of Minnesota, local governments and community stakeholders on this topic. Our communities have many knowledgeable people on this topic and we want to get them in the same room with us to be more creative about solutions and making them happen."

This tri-city effort is being sponsored by the University of Minnesota Sustainability Studies Minor program, the Cities of Lauderdale, Falcon Heights, and St. Anthony Village, and Minnesota GreenStep Cities.

## ELECTRICAL PERMITS

Are you planning on having any electrical work done on your house? If so, you can obtain your electrical permit at St. Anthony City Hall during normal business hours. Before, all electrical permits were processed through the State of Minnesota.

The St. Anthony City Council recently approved an ordinance allowing the City to issue electrical permits. This process will give residents the one stop shop when needing multiple permits. The electrical permit is available on the city's website as well as stopping at City Hall. ## CITY COMMISSION SEAT OPPORTUNITIES

The City has two commissions that are appointed by the City Council and serve in an advisory capacity to the City Council. First, is the **Planning Commission**. There will be three seats available beginning January 1, 2013. The Planning Commission is a paid per month governing body which makes recommendations to the City Council on planning issues such as variances, conditional use requests, zoning issues, etc. They meet on the fourth Monday of every month at 7 p.m. in the Council Chamber of the Community Center.

The **Parks Commission** has two seats available beginning January 1, 2013. This is a volunteer group which advises the City Council regarding the promotion of the systematic, comprehensive, and effective development of park facilities necessary for the overall health and well being of city residents of all ages. They meet quarterly on the second Monday at 7 p.m. in the Council Chambers of the Community Center.

Applications for both city commissions are being accepted until November 16, 2012. If you are interested in becoming a member of either commission, you can complete a Commission Application form that is available on-line or you can pick one up at City Hall. ## The 911 Emergency Process by Mark Sitarz



You are out for a walk with your dog when you witness a man being struck by a car. As you run over to them, you see that they are lying motionless on the ground and a circle of bystanders has begun to form. You hear a shout of "somebody do something". You want to help but you are not sure what you can do so you decide to wait for the first responders to arrive. As the crowd becomes larger, you look down at your watch. What seems like an hour has really only been less than 2 minutes. The thought of calling 911 has popped into your head several times during this whole ordeal. But you keep telling yourself that somebody else has already called and you don't want to bother "them" again for the same accident.

People react differently when they are witnessing or have become a part of an emergency situation. When you are unable to help or do anything at all, time seems to stand still in a very uncomfortable way. Frustration, anxiety and even anger can be felt while you are waiting for help to arrive. You understand that time is of the utmost importance and right now it seems like this waiting game is not going to end. Calling 911 when you first came across this emergency would have certainly shortened this waiting game.

The 911 system was put into place to simplify and to speed up the emergency response process. The sooner those three numbers are dialed the faster the response will be. What people don't understand, however, is that getting the correct information from the caller and passing that on to the first responders can take some time as well.

A 911 operator needs to be able to find out what the emergency is, confirm the exact location (cell phones have made this a bit more challenging), the severity of the situation and any additional information that they feel is necessary. During this question and answer session, the operator may run into a distraught caller who cannot answer simple questions, need a translator if there is a language barrier or may determine that they are sending the first responders into an unsafe situation. Once they have that information, then step two of the process is started and that is to alert the correct agency or agencies for response. All of the information that was previously gathered is now passed on to the responding agency and response time for the emergency units has begun. Depending on the individual operator, the composure of the caller, a possible language barrier and the amount of information needed, it could take up to a few minutes before that responding agency is notified of the emergency. This is why it is important to start the 911 response system as quickly as you can.

The fact that a person thinks about calling 911 does not actually start the process. It is not until the sharing of information with an operator does that process begin. With time being a key factor in getting help to somebody who is experiencing a stroke, a heart attack or even a kitchen fire, we are relying heavily on you the bystander to begin the response process by dialing those three important numbers, 911.


## WINTER PARKING

Residents are NOT allowed to park on ANY street for a period of 48 hours, beginning immediately after two (2) inches or more of continuous snowfall or until the snow removal has been completed from curb to curb.

### ADOPT A FIRE HYDRANT

Precious time is lost when firefighters have to look for and uncover fire hydrants. Please help by occasionally shoveling around the fire hydrants, keeping them accessible in case of a fire. Your assistance is greatly appreciated.

## WINTER PARKING AND SNOW PLOWING

The City's snow plowing crews' number one priority is to clear the snow away to make St. Anthony's streets safe for traffic and emergency vehicles. Here are a few reminders for residents.

Residents are NOT allowed to park on ANY street for a period of 48 hours, beginning immediately after two (2) inches or more of continuous snow fall or until the snow removal has been completed from curb to curb.

Sometimes the crews' schedule for plowing does not coincide with residents' snow shoveling schedules. The crews do not intentionally plow windrows of snow back onto freshly shoveled driveways or sidewalks.

Also, it is dangerous for children to dig tunnels in these windrows created by the snowplows. Tunnels can cave in, smothering the children. Plow drivers also cannot see children playing in or around the windrow. Children can be covered and trapped by these snow windrows.

Other ways to assist with snow removal operations include:

- \* Do not place refuse or recycling containers in the street; and
- \* Do not plow, blow or shovel snow into the street; and
- \* When shoveling, pile snow downstream of the plowing operations to minimize snow left in your driveway from the plow; and
- \* Stay back when driving behind plow trucks.

**DID YOU KNOW.....**The storage of refuse and recyclable collection items may not be kept in the front yard without approved screening or fencing. Once the trash has been picked up, please remember to remove your trash can and recycling bin from the curb and return them to the garage or some place out of site from the road. (Ord. 150.090)

**DID YOU KNOW.....**Parking in any residential district must be done on a surface paved with asphalt or bituminous material, concrete, cement, brick, or other paved surface. Parking vehicles on the grass is not allowed in the City of St. Anthony. (Ord. 152.179 subd. 3)

**DID YOU KNOW....**Any weeds or grasses, whether noxious as defined by law or not, growing outside the traveled portion of any city street or alley, or growing on private property, to a greater height than 6 inches or which have gone or are about to go to seed must be cut or removed by the owner of the property if the weeds are outside the right-of-way. (Ord. 94.32)

**DID YOU KNOW.....**Any vehicle without a current state registration must be parked in a garage or other building. If a vehicle has expired tabs, either renew them or move the vehicle into the garage. (Ord. 152.179 subd. 4)

**DID YOU KNOW.....**Travel trailers, campers, and other recreational vehicles may not be parked in any zoning district for use as a dwelling or for sleeping or housekeeping purposes. (Ord. 152.179 subd. 10)

**DID YOU KNOW.....**Before lighting a recreational fire, you must first call the St. Anthony Fire Department. You will receive a copy of the rules and review them with a member of the Fire Department. The Fire Department may prohibit any or all recreational fires when atmospheric conditions or local circumstances make such fires hazardous. Call 612-782-3400.

Please remember these ordinances have been put in place to keep St. Anthony clean, safe, and healthy. ## ADDRESS NUMBERS by RICK LUNDEEN

Emergencies have no season...they never take a vacation. But whenever the call comes, morning, afternoon, rush hour, or those dark hours before dawn, seconds count!

That is why our Fire and Police Departments are asking everyone to post the correct address in a conspicuous place on your home or garage. The numbers should be at least 4" in height and 3/8" wide so they can be easily read by a person while seated in an emergency vehicle located in the street or coming down your alley. (St. Anthony City Code 97.10)

This is just a reminder to the homeowners that don't have numbers on their home or garage or those who have numbers not visible or hidden from view. The color should be contrasting to the house or garage. Please try to keep tree limbs and shrubs trimmed away from numbers.
