Dear Residents,

My brother's keeper, which includes sisters too, has been a saying that has been around for a long time. Does it still have relevance in today's world?! When we look at history, 70 years ago WWII ended and we thought that would do it—well it did for those fascist individuals but there were other oppressed people to follow. We know that we must lend assistance to those who are in need but of course the geopolitics and rhetoric proceed before any actions are taken at the international level. But what about the local level, what are our responsibilities?

The city has had many neighbors recently host Night to Unite gatherings where we take back our power and reach out to our neighbors in an open and friendly manner thereby extending ourselves to each other. There is no better way to live the motto of my brother's keeper than through your neighbors and those around you.

Collectively we do this through our public safety services (police and fire) by providing resources that are professional trained and effective. It was not that long ago that my grandparents native language was not English, but German and Norwegian, as I am sure many of you can say the same thing.

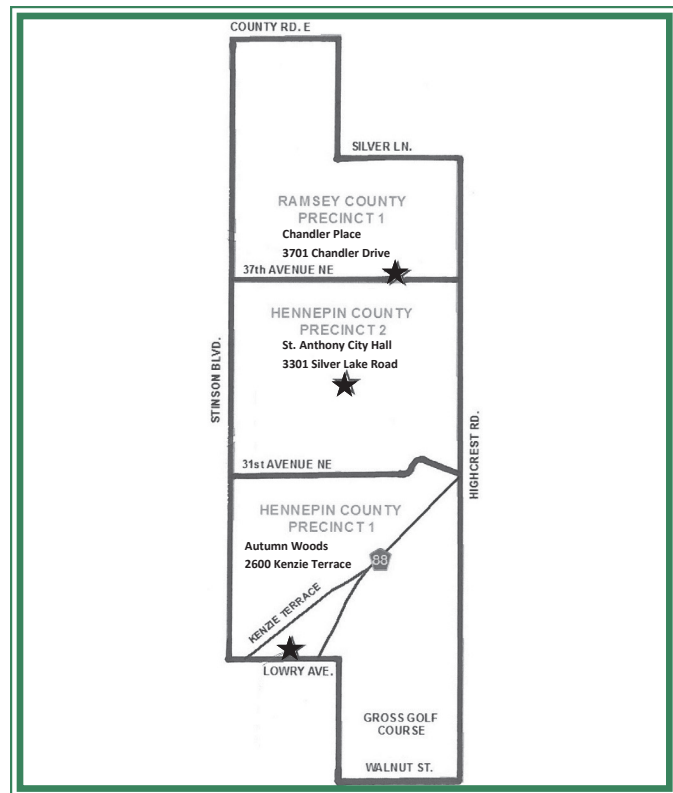

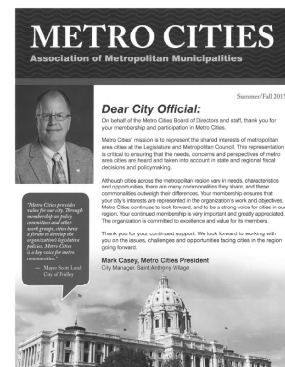


## **BATTERIES DISPOSAL**

## **SUSTAINABILITY ... ENVIRONMENTAL, SOCIAL & FINANCIAL**

Sustainability can be defined in many ways, commonly supported by the three pillars of environmental, social and financial. The Mayor's article on the front page helps us connect with social sustainability as we welcome our changing demographics. As we are actively working on our short and long term budgets and financial plans, we strive for financial sustainability to achieve a structural balance.

I would like to bring attention to several environmental activities of note coming this fall. For the past four years, we continue to work with the University of Minnesota's Sustainability Studies Program's Sustainable Communities class. This fall, students will work on several projects that will be showcased at the 3rd Annual Sustainability Fair on Thursday, November 19th from 5:30 p.m. to 8:00 p.m. at Silverwood Park. The Sustainability Fair is free and all are welcome to attend. One of the projects is a model "Green" home. St. Anthony resident Roy Quady has graciously opened up his 1950's – era single-family detached rental home as a showcase for sustainable innovation and a model for similar homes in the City. Drawing on inspiration from Leadership in Energy & Environmental Design (LEED) and the Living Building Challenge, students will develop detailed recommendations to be implemented along with providing educational resources for other residents in the community. Another class project will address how we can increase the use of home energy audits to identify and implement projects to reduce greenhouse gas emissions. Energy Squad & Energy Fit Homes are two such programs the students will be exploring. We hope these and other projects on display will inspire residents to take action in our community.

We are also proud to announce the placement of a GreenCorp member for the next eleven months beginning this fall. As part of the AmeriCorp program, our GreenCorp member, who will be funded by the MPCA, is a recent college graduate who will assist the City in our numerous sustainable initiatives.

Through local/regional collaborations, the City has recently engaged in several significant infrastructure projects such as the Central Park Bio-swale, the Silver Lake Treatment Facility at Salo Park and the Regional Stormwater Treatment and Research Facility, which combined, will be capturing stormwater from over 680 acres or nearly half of St. Anthony. In addition, beginning next year, the Mirror Lake flood and water quality project will commence.

We invite you to participate in TechDump on October 17th from 9:00 am to 1:00 pm. At no cost, your electronic items may be dropped off at City Hall for recycling. Proceeds support the non-profit Job Foundations which provides stable jobs to adults with barriers to employment. Finally, a Fix-It Clinic will be held on Saturday, October 10th at City Hall from noon to 4:00 pm. You can bring in small household appliances, clothing, electronics and more...with free guided assistance, you can disassemble, troubleshoot and fix your item.

Sustainability is front and center in our city's mission statement. Through initiatives such as those discussed here, the City of St. Anthony is living its mission, ensuring that sustainable practices become woven into the very fabric of our community and local culture. Please join us at the Sustainability Fair on November 19 and learn about current efforts and find out what you can do to help our community become more sustainable.



## **FIRE PREVENTION REMINDER**

This year's National Fire Prevention Association (NFPA) Fire Safety Week message is "Hear the Beep Where You Sleep." Stressing the importance of having a smoke detector in every bedroom, outside each separate sleeping area, and on every level of your home, including basement areas. According to the NFPA, around half of all home fire deaths result from fires reported between 11 pm and 7 am. These are the times when most families are sound asleep.

Some people, especially children and older adults, may need help to wake up. Having a smoke detector in each bedroom helps assist even the soundest of sleepers in waking during a fire. Keep in mind, if you or someone you know suffers from hearing loss, other notification systems may need to be installed.

Ideally, for the best protection, interconnected smoke alarms should be installed. This allows the detectors to communicate with each other. When one detector is set off, they all sound. This helps notify all areas of the house giving all occupants immediate notification of a possible fire.

Smoke detectors are on guard 24 hours a day watching over you and your family. They are working even when you are sleeping. Make sure to protect those that you love by installing this simple yet effective family safeguarding tool. They are doing their job to make sure you are able to get up and go to yours.

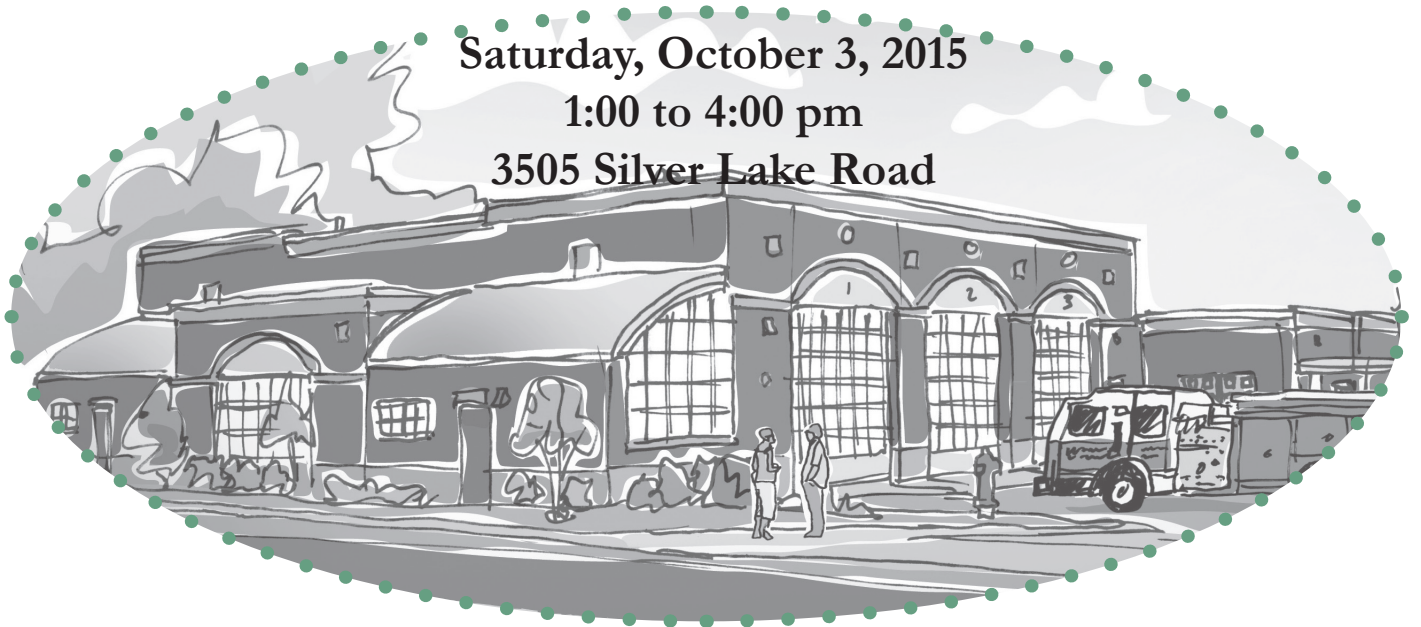

## **DISTRACTED DRIVING, WHAT YOU NEED TO KNOW**

Distracted driving has attracted significant national attention as of late and the safety implications that it has on the overall safety on roadways. There are many activities that occur regularly on roadways that divert a driver's attention and put an increased risk on those in and around the distracted driver. These activities include, but are not limited to, texting, cell phone use, eating, reading, operating a navigation system, and interacting with passengers.

Actions which take a driver's attention away from their primary responsibility of operating a motor vehicle safely can have, and has had, dire consequences. According to the National Highway Traffic Safety Administration (NHTSA), 10 percent of all fatal crashes, 18 percent of all injury crashes, and 16 percent of all motor vehicle crashes in 2012 were related to distracted driving activities. These crashes resulted in the deaths of 3328 individuals and injuries to an estimated 421,000.

A particularly alarming statistic involving distracted driving centers around young people who are overrepresented in distracted driving crashes. All things considered, motor vehicle crashes are the leading cause of death for U.S. teens. When teenagers are handed the keys to a motor vehicle, they are being sent out to perform a task that has the highest likelihood to lead to their death. While these statistics are frightening and unacceptable, there are things that can be done and are being done to reduce the risks. This involves enforcement of laws, education, and personal responsibility.

Nearly everyone knows someone who has been the victim of distracted driving. Ultimately each driver needs to decide and take measures to reduce distractions as much as possible. It is also the duty of parents and guardians to educate themselves and their teen drivers as to the pertinent laws and dangers of distracted driving. A safe driving experience starts with you. When you're free of distraction, a safe and enjoyable driving venture will likely be the result. As your Police Department, we look forward to working with the community to make our roadways a safer place.

## **THE IMPORTANCE OF COMPREHENSIVE PLANNING**

Imagine it's 2040. Your community has been transformed by the people, politicians, staff, and businesses into a place they intentionally set forth to create. What would that look like? What would be the components of an idyllic place to live, work, and play? In the coming months, you will have the chance to influence the future of St. Anthony through an update to the city's comprehensive plan.

The Metropolitan Council requires each community in the Twin Cities metro area to update to their comprehensive plan every ten years, and they provide a three year window to complete it (January 1, 2016 to December 31, 2018). The Metropolitan Council recently released community system statements that outline the impacts on the regional systems, including water resources, wastewater, transportation, parks, and housing. New this year is the Housing Policy Plan, which includes important information about how your community plans for housing opportunities for the growing number of households in the metropolitan area.

Stay tuned for more information on the Comprehensive Plan process, and how you can get involved in shaping St. Anthony's future.

## PLANNING COMMISSION

The Planning Commission is a seven person commission that meets the fourth Monday evenings of each month beginning at 7 pm in the Council Chambers. We review land use and development applications resulting in a recommendation to the City Council. When there are no applications to review, we study items in our work plan.

In the past three years, the Planning Commission has created a work plan to be reviewed and approved by the City Council. The 2015 Work Plan includes a list of potential ordinances to review and/or amend in our City Code. This past spring, we provided a recommendation to Council regarding the ordinance on solar energy. Next on our list to review is the ordinance regarding Urban Farming/Keeping of Animals.

## CITY COMMISSION OPPORTUNITIES

The City of St. Anthony is seeking applicants for the Planning and Parks Commission. The **Planning Commission** will have three seats available beginning January 1, 2016. This is a paid per month governing body which makes recommendations to the City Council on planning issues such as variances, conditional use requests, zoning issues, etc. This commission meets on the fourth Monday of every month at 7 pm at the Community Center.

The **Parks Commission** will have two seats available beginning January 1, 2016. This is a volunteer group which advises the City Council on promotion of the systematic, comprehensive, and effective development of St. Anthony's park facilities. This commission meets on the second Monday of each quarter at 7 pm at the Community Center.

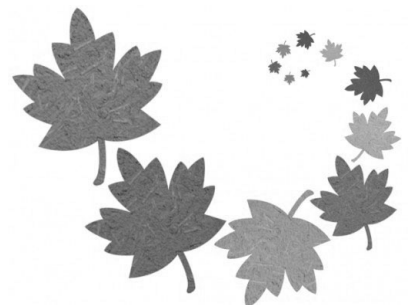


## SUSTAINABILITY IN A VOLATILE BUSINESS ENVIRONMENT

Achieving and maintaining financial sustainability is a constant pursuit in any business. The City's Liquor store operations are no different. Therefore, the City manages its use of Liquor profits to ensure the vitality and health of Liquor operations. That process has been tested over the last two years. Liquor sales have been impacted by increased competition in the marketplace along with the relocation of Wal-Mart. The City's practice of banking one to two years of prior profits within the Liquor Fund provides a window of time to adjust to changing conditions.

The Liquor operations cash flow beyond the banked funds are used to lower the cost of City services. The 2016 budget anticipates using approximately \$250,000 of Liquor store cash flow for this purpose. This amount represents a reduction of approximately \$146,000 from the 2015 Liquor operations contribution. More recently, the Liquor store sales have shown positive gains over prior year's results. Earned revenue of \$250,000 provides a substantial benefit to the City's residents, warranting the sustainability approach.



## ADOPT A FIRE HYDRANT

The St. Anthony Fire Department appreciates residents who help keep the snow cleared away from pathways and fire hydrants. Accumulation of excess snow can block the view of responding fire personnel to fire hydrant locations. Precious time is lost when firefighters have to look for and uncover fire hydrants. Occasionally shoveling around the fire hydrants keeps them accessible for firefighters in case of a fire. Thank you for your assistance in making St. Anthony a safer community!

City crews will be dispatched to evaluate the situation and assist the property owner. Remember, the property owner is responsible for maintaining water or sanitary sewer service from their building up to and including the connection to the main water and sewer lines.

## WINTER PARKING AND SNOW PLOWING

During the winter, the number one priority of the Public Works department is to clear the snow and make St. Anthony's streets safe for traffic and emergency vehicles. Here are a few reminders to assist residents in achieving this goal:

Residents are NOT allowed to park on ANY street for a period of 48 hours, beginning immediately after two (2) inches or more of continuous snow fall or until the snow removal has been completed from curb to curb.

The City understands that sometimes the schedule for snow removal doesn't correlate with residents' snow shoveling schedules. The snow plow drivers do their best to avoid pushing windrows of snow back onto freshly shoveled driveways or sidewalks.

Remember it is dangerous for children to dig tunnels in the windrows of snow created by the snow plows. Tunnels can cave in, smothering the child. Plow drivers can't see children playing in or around the windrows and they can be covered or trapped in the snow.

Other ways to assist with snow removal operations include:

- \*Don't place refuse or recycling containers in the street; and
- \*Don't plow, blow or shovel snow into the street; and
- \*When shoveling, pile snow downstream of the plowing operations to minimize snow left in your driveway; and
- \*Stay back when driving behind plow trucks.

With your cooperation, snow removal can be more efficient and roads cleared in very little time. ## SILVER LAKE STORMWATER TREATMENT SYSTEM NOW OPERATIONAL

Construction was completed earlier this summer on the Silver Lake Stormwater Treatment System in Salo Park, just north of 39th Avenue in St. Anthony Village. The underground treatment system, located along the bank of the north pond, was constructed in order to help the City achieve its required discharge reduction of phosphorus into Silver Lake.
