

WHAT IS GOING ON WITH WAL-MART?

For many months the city has been asked, "What is going on with Wal-Mart?" To begin, when Wal-Mart was built in 2005, they signed a 20-year ground lease with the owner of the property, which requires continued payment and maintenance of the property. The owner of the property, Inland, is a vested partner in ensuring the overall development is successful. Additionally, it would not be in Inland's best interest to have a major anchor tenant vacant.

Inland Commercial Property Management, Inc., a publically traded, national real estate corporation based out of Oak Brook, Illinois, has numerous investments throughout the Midwest, including several located in the Twin Cities area. We are confident Inland has the connections and resources to continue to provide a superb retail experience at Silver Lake Village.


Rick Pleassner, Vice President of Inland, spoke at a City Council meeting and stated, "Inland is the proud owner of Silver Lake Village. The amount of volume done at this Wal-Mart store is astronomical and we are shocked that Wal-Mart would close this store, but Wal-Mart has announced to the public that they intend to close in April this year. Inland is obligated to wait three years after the closing of Wal-Mart before it can take possession of the store and Inland is currently negotiating with Wal-Mart to obtain unrestricted control of the property in order to lease it to a new tenant. Inland wants the community to know that they have a significant investment in this property and are committed to keeping the city informed of its negotiations with Wal-Mart and its progress in finding a replacement tenant."

So often the expression of "location, location, location" is used when describing the value of real estate. We feel the Wal-Mart building is aesthetically appealing, has great access and signage, and is in a prime location that benefits from the synergy of the Silver Lake Village commercial retail and residential development.

Although we are closely monitoring the situation, it is not the city's role to procure the future tenant. Rather, it is our job to ensure that the appropriate zoning is in place for the highest and best use of the property as prescribed in the city's zoning code of allowed uses.

WHAT IS ZONING?

Zone (verb) - Divide into or assign zones, in particular.



Local governments and land-use planners use "zoning" as a way of designating uses of land in varying mapped zones which separate one set of land uses from another. Zoning can be use-based (regulating the uses to which land may be put, also called functional zoning) and similar performance characteristics, or some combination of these.

In other words, zoning allows a community to control the development of land within the community - whether this is residential, institutional, commercial, or industrial. This important tool aids communities in guiding development so that land is used in a way that promotes both the best use of the land and the prosperity, health and welfare of the city's citizens.

Typically, zoning is accomplished by dividing the land into different districts or zones and regulating the uses of land within each district. By creating zoning districts that separate uses, the city assures that adequate space is provided for each use and that a transition area or buffer exists between distinct and compatible uses. This separation of uses prevents congestion, minimizes fire and other health and safety hazards, and keeps residential areas free of potential commercial and industrial nuisances such as noise, light and dust or smoke. 

HELP! DON'T FLUSH

The Public Works Department is asking for your help. In recent years we've seen the introduction of more disposable wipe products for a diverse range of household uses. Quite a few of these products are labeled disposable and some flushable. The truth is that these products may cause a huge inconvenience to home-owners, businesses and to our City's sewer system by creating a clog or blockage.

Unlike toilet paper; these wipes will not break down once they're flushed. They can then cause blockages in your home or businesses



sewer line, particularly in older pipes that may already contain grease, roots or other obstructions, resulting in a sewer backup into your home or business. These repairs can often be expensive and often not covered by insurance.

These products affect our public sewer system. They collect together and cause clogs in our collector lines or often get tangled in the sanitary sewer lift pumps. When the pump stations get clogged, they stop working which can cause a much larger backup and have an effect on many homes and or businesses. The pumps then require cleaning and repair or possible replacement in order to get the sewage moving again.

We need your help in preventing sewer backups. Please don't flush anything down the toilet that isn't toilet paper or human waste. This will prevent all of us from possibly a nasty cleanup and expense.

Here are some examples of products that you should not flush down the toilet: diapers, disinfecting wipes or baby wipes, moist towelettes, Swiffer wipes and paper towels.

RECREATIONAL FIRES



A reminder that in our city we require a recreational fire permit in order to have recreational fires in your yard. The permits are free and, last year, we moved to a 5 year permit rather than an annual renewal. The reasoning for this permit is to allow us to educate you on the rules associated with recreational fires and to make you aware of the process that we have when the DNR issues a fire ban. Stop by the fire station, fill out the application and walk out with a 5 year recreational fire permit.

HOUSING CODE CORNER

As spring approaches, these are some of the ordinances in the city to be aware of:

Garage Sale Signs: These are prohibited from being affixed to Utility Poles and Fences 155.22. A City Code Inspector will remove any sign attached in this manner. Signs that are allowed cannot have a surface area exceeding 4 square feet and if placed on private property shall have permission of landowner. Signs must be 10 feet back from right-of-way and cannot be displayed for more than 3 consecutive days.

Refuse Containers in the Front Yard: The storage of refuse and recyclable collection items may not be kept in the front yard setback. Code 150.090. On trash pick-up day, please remember to move your trash cans and recycling back into your garage or out of sight once they have been emptied.

Yard Cover: Homeowners\Landowners may not permit or maintain on the land any growth of weeds, grass, brush, or other rank vegetation to an average height greater than six inches. Code 150.094 Subd E. Please remember to keep your grass cut and weed free.

HENNEPIN COUNTY ASSESSOR'S OFFICE

In early March, the Hennepin County Assessor's office sent a notice to homeowners identifying the market value for the 2014 Assessment and Taxes Payable in 2015. If you feel that your market value is incorrect, please contact the assessor's office. Many property owners' concerns can be explained or resolved simply by making a phone call to the assessor's office.

Hennepin County will be holding an open book meeting on **Monday, April 21st** from 5:00 p.m. to 6:30 p.m. in the St. Anthony Council Chambers. Open book meetings are an alternative to the Local Board of Appeal and Equalization. During "open book" meetings, the valuation and classification issues are handled by the assessor's staff on a one-on-one basis with the property owner.

The open book meeting will provide a forum for property owners to meet with Hennepin County Assessing Staff on an informal basis to review information about their property and to ask questions about their assessment. If you have further questions, call Melissa at 612-803-0656.

SUMMER SAFETY TIPS FOR KIDS TO MAKE THEIR TIME FUN AND ENJOYABLE

Outdoor Play

Kids are usually encouraged to go outside and be active. It gives them time to play in the sun, explore the world around them and make new friends. There are, however, some areas that are not safe for children.

Talk to your kids. Tell them that it is best to avoid certain areas, because they can be hazardous. Places such as local canals, lakes and rivers will seem like a great place to spend the day and cool off in the water, but they can also be deadly. Young children should never get into a body of water unsupervised, especially if that water is moving. Other locations such as alleys, underneath bridges and abandoned buildings may also be dangerous. Assure them that your only concern is their safety and you would never want anything bad to happen.

Most importantly, discuss with your children why they should avoid strangers. Talk to them about being polite to adults, but keeping their distance from people they do not know. Stress that they should never take any item from a stranger, and under no circumstances should they get into an unfamiliar vehicle. Let them know that if they feel frightened or threatened by someone they don't know, they have permission to run away.

Encourage your kids to stay with a group of friends anywhere they go. A predator will be far less likely to approach several kids at once than a child who is alone. If something does go wrong, another member of the group can run away to find help. Give your children a list of important contact numbers including your direct line at work, 911 and other emergency services. If your child has a cellular phone, make sure these numbers are programmed into the phone.

THE LUCAS 2 DEVICE by Fire Chief Mark Sitarz

One of our best assets is time when it comes to an emergency situation. Whether it's a fire or medical scene, it doesn't matter. What counts is that we get there quickly and safely and that we perform well with the tools we use and the training we have.

Last year the Fire Department added a very important piece of equipment to our medical toolbox. It is called a Lucas 2 device and it performs mechanical chest compressions during CPR.

Over the past few years, the medical community has done a wide variety of research on CPR and first responders. What they were looking for is that perfect mix of depth of compressions, speed of compressions, manual breaths and early defibrillation. Various studies were performed on pigs and a lot was learned through this process. What they walked away with was that first responders were actually over oxygenating patients and compressions needed to be more consistent on depth and speed. Over time of performing compressions, personnel were becoming fatigued and inconsistent and, depending on the size of the patient, this was happening quicker or with more severity. On top of that, breaths were given too quickly causing over oxygenation of the blood.

Various companies took this information and developed a number of mechanical chest compression devices. The range is wide and there are pro's and con's with all of them. The goals in mind were to provide those consistent compressions in depth and speed and also a device that could easily be setup causing minimal downtime between compressions allowing us to keep the "pump primed."

We chose the Lucas 2 device which we felt provides us with that consistency and ease of use causing minimal interruption between compressions, setup and activation. The cost of this device was \$15,000 and it was paid for by funds from the City, the St. Anthony Fire Department Relief Association and a grant from the Minnesota Resuscitation Consortium.

Training has been given to all members of our department and the Lucas 2 device has been used on various cardiac arrest calls with positive results. Once in place, we have been able to free up a set of hands to perform other key tasks at a cardiac arrest. We are also using this in conjunction with a device called a ResQPOD which increases blood flow dramatically and has proven to work well with the Lucas 2.

Time, training and tools are key to what we do for the community we serve. Our commitment to you, the residents, is in what we can do with all 3 of those during a difficult situation. We want to say thank you for giving us the tools to do our jobs. We are committed to using our time wisely and training on what we have in our toolbox with the goal of a positive outcome for all involved.



2014 STREET AND UTILITY RECONSTRUCTION PROJECT

This year's street and utility reconstruction project will consist of the following areas:

- Penrod Ln from 36th Ave to 37th Ave
- Edgemere Ave from Penrod Ln to Chelmsford Rd
- Wendhurst Ave from Penrod Ln to Chelmsford Rd



Bids were received and the contract was awarded to R.L. Larson Excavating, Inc. of St. Cloud, MN. The project documents are currently being executed with an anticipated start date of early May depending on weather. 2013 STREET RECONSTRUCTION PROJECT

Work is anticipated to resume on the last year's street and utility reconstruction project in early May or as the weather permits. The contractor's first task will be to remove and replace any settled or cracked concrete curb and driveway panels. Following concrete replacement, the contractor will re-grade and/or re-seed any yard settlements or areas where turf has not established. SILVER LAKE CARP REMOVAL

Last summer, the City of St. Anthony and its partners New Brighton, Columbia Heights, Rice Creek Watershed District, and Three Rivers Park District captured, radio tagged and tracked the movements of seven carp in Silver Lake. Seventy more carp were captured and their fins clipped to assist in determining how many carp are in Silver Lake.

This winter, the radio tagged carp gathered together under the ice, and commercial fishermen attempted to net the carp and remove them from the lake. During the carp harvest, the net snagged on some underwater debris and tore half of the fishermen's net allowing many of the fish to escape capture. However, the fishermen were still successful at catching 400 carp with a total weight of 4,000 pounds and removed them from Silver Lake.



Based on the clipped fin counts, we estimate that 40% of the carp have been removed from the lake. Three radio tagged carp were also captured and released back into the lake to help track the remaining 60% of carp that we may attempt to remove either this year or next.

Carp are being removed to restore the ecology of the lake and to improve water quality. Currently, carp are consuming most of the plants in the lake and continually stirring up bottom sediments reducing the clarity of the water. Removing the carp should encourage plant growth and improve water clarity. Carp removal is one tool being used to achieve the State Mandated Water Quality goals for Silver Lake.

How time flies! 2014 marks 10 years in our current store locations. Seems like yesterday when our new stores opened! While 10 years is only a small portion of time considering our 66 year history, our sales and profits are greater than ever. During the last 10 years, St. Anthony Village municipal liquor stores have generated over \$65,000,000 in sales and poured in (pardon the pun) over \$4,000,000 in net profits to the community! Our profits have been used for capital equipment purchases for City Hall, Public Works, Police and Fire Departments, and city projects such as the skateboard park.


SILVER LAKE STORMWATER TREATMENT SYSTEM

The City will be constructing an underground system to treat stormwater runoff next to Salo Ponds starting in March 2014. The treatment system will be used to assist the City with reducing the amount of phosphorus in the water which discharges from the ponds to Silver Lake.



This project is necessary because Silver Lake is currently listed as impaired for nutrients and algae by the Minnesota Pollution Control Agency (MPCA). Due to this impairment, the City of St. Anthony is to reduce phosphorus runoff into Silver Lake by 31.5 lbs. per year.

Salo Ponds are located in Silver Lake Village, an area that has undergone recent development. The system will draw water from Salo Ponds, inject a chemical that will bind to phosphorus in the stormwater, and then allow the phosphorus to settle out in a settling tank. The treated water will be discharged back into the ponds.



This system is anticipated to increase the phosphorus removal efficiency of the existing Salo Park stormwater ponds from 54% to approximately 90%. This may remove nearly 26 lbs. of phosphorus per year that would have been sent downstream to Silver Lake. With this one project, the City will be able to achieve 85% of its phosphorus load reduction requirement.

Grant funding was received for half of the \$432,000 project cost through the Public Facilities Authority administered by the MPCA. Rice Creek Watershed District contributed an additional \$50,000 to the project and the remainder will be paid by the City of St. Anthony.

Construction of the treatment system is scheduled to be completed by June of 2014 and the system will begin operation in the summer/fall of 2014.
