While searching the building, two suspects appeared at the front door. They were advised to stop and complied. The suspects were both identified as 18 year old males. Both males were interviewed and booked at the Hennepin County Jail for 2nd degree burglary. Via interviews, a 3rd 18 year old male suspect was identified that was initially part of the burglary, but left prior to police arrival. No loss or damage was located inside the school. After speaking with school staff, it was determined that the offense will be handled at the school level and no criminal charges will be filed.</p>

Ramsey County Child Protection was contacted and the child was placed in protective custody. Reports and photos were received regarding the infants injuries and neglect. The parents, a 19 year old male and a 25 year old female, were later interviewed, with an investigator and a Ramsey County Child Protection worker. This case was referred to the Ramsey County Attorney for charges, against both parents, of felony malicious punishment of a child under for 4, gross misdemeanor malicious punishment of a child causing less than substantial injury, and gross misdemeanor neglect or endangerment of a child.</p>
