All evidence was seized. Due to the fact that the alarm company and officers were unable to contact a keyholder, or employee, a boarding company was called to board up the business. It appeared several display phones were missing, but due to no employees on scene, the loss is undetermined at this time.

While on scene, a Minneapolis PD officer advised that he had just observed a 41 year old male known to have a felony warrant. The area was checked, the suspect was located and placed under arrest. Located on the suspect were multiples tools consistent with burglary tools, a methamphetamine pipe and a small amount of methamphetamine. The suspect was booked at the Hennepin County Jail for felony possession of a 5th degree controlled substance. Further investigation, located a second male inside the vacant business. Officers confirmed that this male was a maintenance worker with permission to be in the business.</p>
