Note from the Mayor

Dear Residents,

One of the items I highlighted last newsletter, was the National Mayor's Challenge for Water 2019! The Challenge took place from April 1 through April 30, 2019. It was an opportunity for each of us to commit ourselves to preserving a most precious resource – water. I am proud to say that St. Anthony Village residents really stepped up to the plate in pledging to save water – we placed 28th in the category of cities with a population of 5,000 - 29,999. That put us in pretty stiff competition with a population of 9,000. Two larger cities in Minnesota out pledged us in water savings but when you consider the size of White Bear Lake (#8) and Rosemount (#10) we did very well. A big thank you for all who participated!

Of course, summer means fun in Minnesota but it also means road construction. Silver Lake Road needed a much-needed storm sewer main replacement to eliminate some flooding issues also later this summer Ramsey County will do a mill and overlay from 37th Ave to I-694. The Ramsey and Hennepin counties and city are doing work on County Road C adding a sidewalk and bike lane. In addition, some flood storage areas are being planned to help the industrial park in that area. We will be adding a turn signal on Silver Lake Road and 33rd Avenue to aid in traffic flow to the school.

Events that are planned for your outdoor enjoyment are the Summer Concerts in Salo Park on Thursday evenings at 7:00 PM. Then there is Village Fest on August 2-4 with a Chamber of Commerce Golf Tournament on Friday with an evening parade; Central Park band, food activities on Saturday with evening fireworks and a Kiwanis waffle breakfast following Sunday morning. A great time to meet new friends and enjoy their company. Speaking of knowing new people and sharing in your neighborhood, on August 6th is Night to Unite a wonderful neighbor to neighbor block party. Police and Fire department personnel and equipment will come to answer questions and this has always been a big hit with the children. Consider being a block party organizer and sign up with the PD – see further information on inside.

The council has been conducting “Coffee with the Council” each month at various locations throughout the city. It is a great time to informally talk to the council about city related issues in an informal way over a cup of coffee – take advantage of our offer.

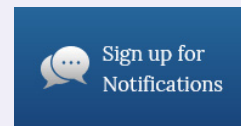
WAYS TO CONNECT AND ENGAGE

SIGN UP FOR NOTIFICATIONS!



Visit www.savmn.com and select Sign up for Notifications located in the center of the homepage. You can choose to receive notifications by email, text or both!

Notify Me-Sign up to receive updates on specific subjects.

Alert Center-Sign up to receive updates on snow plowing and public safety alerts.

Government Jobs-Sign up to receive notifications when a new job has been added or modified.

News Flash-Sign up to receive notifications of added/modified news flash items. We typically use the news flash for highlighting certain events, initiatives and important messages.

Calendar-Sign up to receive notifications of added/modified meetings and community events.

Ask the City-Use this form to ask City staff questions.

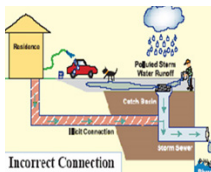
ILLICIT DISCHARGE FACT SHEET

Have you ever seen your neighbor blowing leaves or lawn clippings into the street? Or how about seeing someone dumping paint or used oil into the storm drain? Have you ever seen any murky water running down the ditch? What we do at home affects our local water resources because our storm drains and ditches are connected to nearby lakes, rivers, and streams. Remember, **only rain down the drain**. If discovered, please contact the City at 612-782-3301.

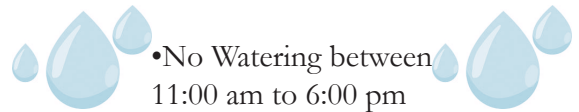
As an MS4 (Municipal Separate Storm Sewer System) community, St. Anthony regulates non-stormwater discharges to the storm drainage system. The City's Code Chapter 50: Storm Water and Sanitary Sewers, Section 50.30 – Illicit Discharge and Connection contains enforcement actions the City can take in the event an illicit discharge occurs.

Sources of Illicit Discharge:

- Sanitary wastewater
- Sediment from construction site runoff
- Landscape waste
- Paints, solvents
- Used oil, radiator flushing, grease
- Cleaning products
- Spills from accidents
- Improper disposal of household toxics
- Laundry wastewaters
- Illegal connections to the storm sewer system
- Commercial car wash wastewater



WATER RESTRICTIONS



•No Watering between 11:00 am to 6:00 pm

- Odd numbered addresses may water on odd dates
- Even numbered addresses may water on even dates
- Exemptions may be granted for recently established lawns
- Water restrictions shall apply each year

WATER & SEWER EMERGENCIES

If you have a water or sewer emergency, contact city offices immediately at 612-782-3301 during normal business hours.

For after hours service, contact the Fire Department at 612-782-3400 or 911. City crews will be dispatched to evaluate the situation and assist the property owner.

Remember, the property owner is responsible for maintaining water or sanitary sewer service from their building up to and including the connection to the main water or sewer lines.

Reminder

I & I (Inflow/Infiltration) inspection is required by the City prior to the sale of a house.

UPDATES FROM THE POLICE CHIEF

A key focus for our department is and has been building relationships. Community Engagement programs provide education, but equally important is instilling confidence in our communities that our police officers are trusted resources that can be counted on to work in their best interests.

We, as police officer's, must keep in mind that every encounter is a community engagement opportunity. It's the lens by which we view all of our activities. It's what marks the difference between a police department that participates in community engagement events versus a department whose driving philosophy is community engagement.

We recently hosted our annual "Summer Survival" camp for kids on June 18th and 19th. The camp is a two day event for school aged children in which they are presented with different demonstrations from Police, Fire, and EMS organizations. We showcase Police K-9s, water patrol boats, fire trucks, teach safety skills, weather safety, drug/alcohol and tobacco education and prevention, and we even get a visit from the State Patrol helicopter. Events that we will be focusing on as we continue through the busy summer months include MN Night to Unite (August 6th) and Village Fest (August 2nd – 4th).

In relation to Community Engagement programs, we utilize social media to promote transparency and engagement with community stakeholders through the application of various platforms available mainly through mobile applications.

These applications include Facebook, Instagram, Twitter, and Snapchat. We utilize these platforms to disseminate information (sometimes in real time) for recruitment, engaging media outlets, providing crime alerts, press releases, and profiling our officers to increase approachability and create connections. Of note, our Facebook page has over 2200 followers, Instagram has over 1000 followers, and Twitter has nearly 5000 followers.

With regard to transparency, the police department fully implemented our Panasonic Body Worn Camera (BWC) program as of November 9th, 2018. Officers of the St. Anthony Police Department have embraced this technology and have been diligent in following policy regarding deployment and use. Daily record management reviews are conducted to ensure equipment is being used properly. Department supervisors are required to complete monthly audits to ensure equipment is being used properly and in accordance with policy. Our April audit resulted in a 100% compliance rate. Additional upgrades to our audio and video capabilities in both the squad car and the police department facilities now allow us to capture and record coverage of officer contact with the public through multiple phases of the interaction.

As an agency, we will endeavor to maintain a culture of community service and one that embraces the concepts of community orientated policing.

In preparation for the April 1, 2020 Census, St. Anthony has formed a Complete Count Committee to help build awareness and maximize participation in the Census. INTERNET SAFETY

Do you know what your kids are accessing on their electronic devices? Do you know who their “friend’s” are? Do you know who they are talking to while they are playing video games? Do you know what to do to help you know these things? These are all great questions that we as law enforcement officers get asked all the time. Did you know that 50 percent of victims of exploitation on the internet are between the ages of 12 and 15 years old? FBI statistics show that 89 percent of all advances of exploitation take place in internet chat rooms and instant messaging. As parents ourselves, these are all very alarming to think about. We would like to give you some tips and ideas on how to help parents make sure their children are safe and secure while using the internet.

What can we do to help make sure our children are safe? We can’t be with them 24 hours a day and see everything they do on their devices but there are steps we as parents can take to help give us some sense of security regarding our children’s safety and well-being while using the internet.

Talk to your children and have open and honest discussions about what is out there and some of the dangers of “friending” people they don’t know. Self-educate on some of the dangers of online predators and ways they manipulate children. If you have a web cam turn them off or unplug them when they are not in use as predators have the ability to turn them on and use them even though you aren’t.

There are many internet safety applications out there to download on your child’s phone which helps you educate, moderate and monitor your child’s phone usage. The “apps” have the ability to set time limits, restrict websites, watch for keywords in text messages, monitor text messages, lock the phone remotely and locate the phone through the app. Many of the “apps” are free and some have to be paid for but they are invaluable tools to help your child have the ability to still use their phone while being safe at the same time. These “APPS” can be found in the Google Play Store or the APP Store for Iphones. They can be found under “Parental Control Apps”. Some phone carriers also provide their own safety applications which usually have to be paid for with your monthly billing cycle.

It is always good to set boundaries and guidelines for your children prior to allowing them to use the internet and their devices. If something comes up or if they tell you someone is sending them messages have calm, honest, open discussions with them. Try to learn the computer and text message language they use as there are many abbreviations for many different terms.

If your child has a computer in their bedroom there are screen mirroring applications that allow a parent to see what websites their child is visiting and also shows people they may be chatting with via webcam. This monitoring can all be done by a separate computer in another room.

Technology and social media are ever growing and ever changing and therefore we as parents need to grow and change with it. On Tuesday, August 6th, 2019 from approximately 6:00 pm to 9:00 pm, the St. Anthony Police Department invites St. Anthony neighborhoods to join neighborhoods throughout Minnesota for this fun filled evening.

What is building community?

This is a simple but powerful method for people to improve their own and others' living conditions. At its most basic, this is neighbors working together to create positive changes in their neighborhoods; whether they're trying to reduce crime, look out for each other's property, or get involved in the community. People working together with shared understandings and expectations are what provide an atmosphere of strong community. A strong community sends a message to criminals letting them know that our neighborhoods are organized and fighting back.

Already involved in a neighborhood crime watch group?

NTU will help keep your group active. This is important. Neighbors who know each other and agree to watch out for suspicious behavior are a great defense against crime. If you do not have a crime watch group, NTU is a great way to get neighbors together for the first time and start building relationships. You can make your NTU event as simple or as elaborate as you like. The main point of this evening is for residents to gather as neighbors to affirm their commitment to a safe, healthy community.

Get your children involved in this event. Kids bring great energy and enthusiasm to NTU events. Get all ages busy with your NTU planning this year. Involving children and teens can have a great long-term benefit for your block.

Can my apartment complex sign up for Night to Unite?

Apartment complexes are neighborhoods, within themselves, and are encouraged to plan an event. As you plan your NTU event, try to draw in all the people you can. Everyone benefits when neighbors know each other. The connections that are made and strengthened through NTU carry far beyond this evening.

Will there be ice cream certificates?

In keeping with tradition, the St. Anthony Cub Foods Store (3930 Silver Lake Road) is again partnering with the Police Department in promoting Minnesota "Night to Unite" events. The Cub Store is providing a 5 quart pail of Kemps vanilla ice cream to each resident who hosts a party on August 6th.

How do I register my Night to Unite Event?

Residents with questions, or who plan to host a block party on August 6th are asked to visit the Village of St. Anthony website: www.savmn.com. Click on the link for MN Night to Unite and fill out the request form electronically. You will automatically receive a confirmation email. Please register by Friday, August 2nd. Please fully complete the registration form and note whether you request visits from the Police department, Fire department and city staff and if you will need the Public Works Department to drop off street barricades. The Police Department will deliver ice cream certificates prior to Night to Unite. (Note: to be able to accommodate requests for ice cream certificates, in a timely manner, only those who sign up prior to the August 2nd deadline will receive certificates). The City Public Works Department will deliver street barricades, to the host address, for those that indicate the request on the registration form. SAPD will notify the Public Works reference barricade needs. In addition, we will provide block lists to the St. Anthony Fire Department, the Honorable Mayor, City Council and City Staff.

SUMMER HOME PROJECTS

Summer is a busy time for property improvements by homeowners. Before you embark on a building project, you will want to understand the way the City's land use regulations (like the zoning ordinance) may apply to your plans. There are several categories of requirements, including setbacks, impervious surface limits, as well as height and square footage standards, among others.

If your project is within the zoning allowances, you can typically proceed directly to the building permit stage. Contact City Hall if you have questions about what support documents you may need, which will vary depending on the nature of your project.

If, however, your project exceeds the zoning allowances, you will need additional review before you can get a building permit. Land Use Permits most commonly include Variances to zoning dimensional requirements, and Conditional Use Permits for certain special uses. When you apply for a Land Use Permit, there are additional fees and processing to determine whether or not the City will consider the request.

Variances and Conditional Use Permits require public hearings, notice of which is provided to neighbors and published in the St. Anthony Bulletin. City staff and consultants review the request for consistency with the intent of the City's land use regulations and policies and present those reports first to the Planning Commission for an advisory recommendation,

then to City Council for a decision on the request.

This additional process and time entails additional expense, and those expenses are borne by the applicant. The City's philosophy is that working within the basic rules, results in a clear expectation and relatively predictable outcome. When you seek to exceed the standard allowances, the individual property owner should bear the costs that unique consideration requires. The City charges a basic fee that covers some of the predictable costs – publication, mailing, internal staff time. Review costs are paid for from an escrow that the applicant provides in addition to the fee.

This additional cost can be daunting.

If you decide to seek a land use permit that requires this process, you can help ensure that your costs are minimized by providing complete and clear plans that describe the project, together with a thorough narrative description of the project that lays out the reasons you believe that the City should approve the variance or CUP. Staff is available to assist with the preparation of your application, particularly in laying out the information you will need to support your special request. St. Anthony Village encourages reinvestment in the community. The applicable ordinances are designed to support your ability to maximize your enjoyment of home and property. And enjoy the summer building season!

2018 Street and Utility Improvement Project

The Contractor will continue completing various warranty items, including driveway repairs, replacement of deficient concrete curb, and boulevard restoration along Macalaster Drive, Foss Road, and Highcrest Road. The Contractor is anticipated to complete sidewalk installation along Foss Road and final paving throughout the project corridor in the upcoming weeks.

Silver Lake Road and 33rd Avenue Signal Improvements

Traffic at this intersection experiences periodic backups due to the left turning movements from both east and west bound traffic. Flashing yellow turn signal will be added to the intersection allowing traffic to make a left turn from Silver Lake Road. Installation of the flashing yellow turn signal is anticipated to be complete by the fall of 2019, prior to the start of the new school year.

Silver Lake Road Resurfacing

Ramsey County will be resurfacing Silver Lake Road between 37th Avenue north through the City of New Brighton to Interstate 694 following the City's Silver Lake Road Flood Reduction Project in the summer of 2019. Improvements include milling the top layer of the existing bituminous surface and installing a new, smooth pavement surface. Ramsey County has also begun removal and replacement of deficient pedestrian ramps, medians, and catch basins.

Silver Lake Road Flood Reduction Improvements

Flood improvements on Silver Lake Road consist of the installation of new storm sewer and catch basins along the east side of Silver Lake Road from approximately 250 feet south of Silver Lane to approximately 600 feet north of Silver Lane to address flooding within the roadway. Larger rain events cause the low area of Silver Lake Road to flood causing concern for motor vehicle safety and causing property damage to several homes located east of Silver Lake Road.



This project is a cooperative project that is being funded by the City of St. Anthony, Ramsey County, Rice Creek Watershed District and the Minnesota Department of Natural Resources.

The Contractor has begun construction and is continuing storm sewer installation along Silver Lake Road heading south. Construction is anticipated to be complete by late-July.

Silver Lake Road has been reopened to allow two-way traffic, with left turn restrictions at Silver Lane, for the duration of the project. To accommodate construction operations, lane shifts are anticipated as construction continues.

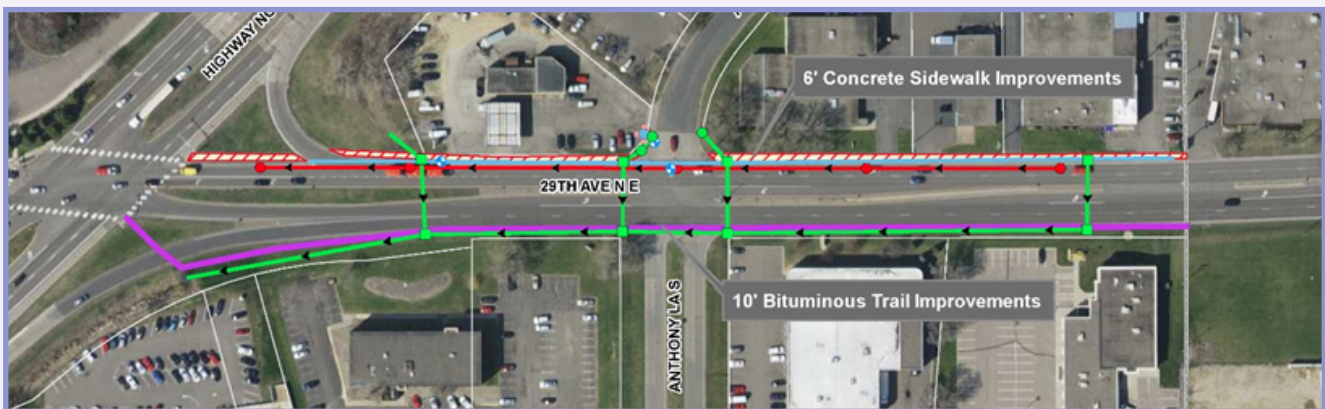
County Road C Reconstruction

Ramsey County and Hennepin County will be reconstructing County Road C (29th Avenue NE) from Highway 88 to Long Lake Road. Improvements along County Road C (29th Avenue NE) within the City of St. Anthony Village (Highway 88 to the eastern City limits) include reconstructing the existing roadway, installation of a 10-foot bituminous trail along the south side of the roadway, installation of a 6-foot concrete sidewalk along the north side of the roadway, and drainage improvements to accommodate area drainage. The County Road C (29th Avenue NE) improvements will also include removal and replacement of the City's watermain and sanitary sewer system.

Bids have been received for the improvements and the contract has been awarded to Forest Lake Contracting.

2019 Reclamite Project



As part of the City's ongoing pavement maintenance, reclamite application has been recommended for 2019. Similar to chip seal improvements, reclamite extends the life of the pavement without the application of loose rock on the surface, making reclamite a more cost-effective option for preserving City roadways. When reclamite is sprayed on the road, it penetrates deep into the surface to reinforce the binder that bonds the asphalt and aggregate together. Applying reclamite to a road improves the asphalt's durability, flexibility and viscosity so it can withstand the effects of the weather, the sun's ultraviolet rays, freeze-thaw conditions, and the weight of traffic.

SUMMER ENERGY & WATER CONSERVATION IDEAS

During the summer season, most residents see energy costs rise with the temperatures. Here are some ideas to consider for reducing energy and water usage, so you can save money on your utility bills while still being comfortable in the heat.

- Thermostats can be set at 78°F, the recommended summer setting to stay cool and save money. If this is not comfortable, find the closest temperature (78° +/- a few degrees) that works best for you.
- Fans allow you to raise your thermostat by 4°F and still feel cool, due to the wind chill effect. Make sure to turn them off if not needed - fans cool people, not rooms!
- Close the blinds during the hottest part of the day to prevent sunlight from heating up your home, especially if you have south-facing windows. This helps trap any cool air you already have inside the house.
- Wash clothes and dishes in cold water. Most energy used by washing machines and dishwashers goes towards heating up the water for the machine cycles.



● Water lawns and gardens at dusk or dawn. This prevents water from immediately evaporating out of the soil during mid-day! Consider a rain barrel to collect rainwater for your irrigation needs, which saves the energy otherwise used while pulling from the city's water.

● Bike, walk or take public transit whenever possible this summer! You'll save some fuel by taking a break from driving, and helping to reduce transportation-related pollution in the area.

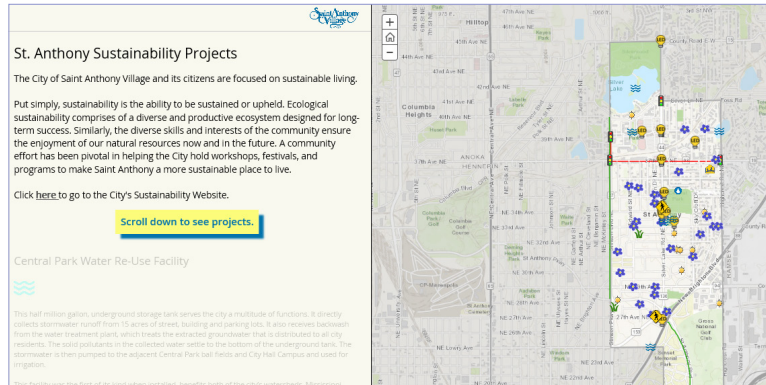
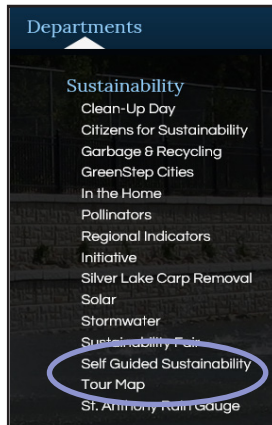
SAVE THE DATE! FRIDAY, AUGUST 23 ST. ANTHONY AT THE MN STATE FAIR!

KICK-OFF TO SUMMERTIME WATER SAVINGS AT CENTRAL PARK

Since the summer of 2008 the Silver Lake Road water reuse system has been a water source to irrigate portions of Central Park. Recent improvements to the reuse and irrigation systems have netted a greater water supply.

Commencing this summer the City will be capturing the Central Park Splash Pad water discharge for irrigation. Once Splash Pad activity heats up, discharge water will supplement the existing water supply to expand irrigation to the entirety of Central Park's 25 acres.

Ideally the additional reuse volume generated will eliminate the use of potable for irrigation at Central Park.

City Staff worked with School District staff to identify the irrigation system modifications needed. This partnership effort with the School District has the potential to save up to 3 million gallons of ground water annually!

PARKS AND ENVIRONMENTAL COMMISSION UPDATE

We have a new name! We are now the Parks and Environmental Commission. Environmental sustainability was added to the Commission's name, mission, and duties this spring by the Mayor and City Council. On behalf of my fellow Commissioners, we look forward to advising the City Council and staff on environmental issues, as well as facilitating community involvement in the development of environmental initiatives.

Finally, as we head into peak lawn mowing season, it's important to think about how our lawn care routines have an impact on water quality. Even if you haven't yet considered a transition to a lower maintenance flowering pollinator lawn, changes in how you care for your turfgrass lawn can help improve water quality.

One way you can improve water quality is to make sure you don't blow grass clippings into the street, where they get washed into stormdrains and end up in local waterways. Grass clippings that end up in nearby lakes, rivers, and streams are basically like fertilizer dumped directly into those waterbodies. To prevent this added fertilizer from reaching local waterways, leave the grass clippings on your lawn and sweep them out of the streets.
