After the assault, the suspect returned to retrieve property and forced the door to the home open causing the damage observed by officers. Due to the damage, the door could not be secured. The victim did not feel safe in the home and officers stood by while a family member responded to the location to pick up the victim. The suspect was located in Columbia Heights and taken into custody. He was booked at the Ramsey County Jail for felony domestic strangulation. The victim was left a message that the suspect was in custody.
