The female was identified and appeared to have physical injuries. An ambulance was called to evaluate the victim. The victim refused to cooperate and left prior to being examined by the ambulance. The suspect was identified as a 46 year old male.</p>

At the time of the theft, the suspect was with her 15 and 12 year old daughters. The adult female was arrested and released with a citation for misdemeanor theft, driving after revocation and careless driving. All three were trespassed from the business.</p>
