The Ramsey County Medical Examiner responded and took custody of the deceased male's body for autopsy. The victim was identified as an 88 year old male. The injured male, suspect, was identified as a 47 year old male. This case was referred to the Ramsey County Attorney's Office to charge the suspect with felony 2nd degree murder.
