| <p>Summary Contains</p> <p>19 year old male arrested, cited and released for reckless driving.</p> |
| <p>A 46 year old female reported that the catalytic converter was stolen off of her vehicle, during the morning hours, while parked in the school parking lot. Loss value undetermined at this time.</p> |
| <p>School staff advised of an unwanted sexual contact that occurred at the school. The mother of a 14 year old female reported that her daughter advised that another student, a 15 year old male, touched her inappropriate and didn't stop when asked. This case is pending further investigation.</p> |
| <p>An employee reported that two suspects filled up two shopping carts of merchandise and left without paying. A witness observed the suspects leaving the store and took a photo of one of the suspects and the suspect's vehicle. A partial license plate was received. The manager estimated the loss at approximately \$400. This case is pending further investigation.</p> |

Store employees advised two males had taken merchandise and placed them in bags and left the store without payment. The males got into a vehicle and fled the scene. The value of the items are unknown.

Arrested a 35 year old male, from Minneapolis, for driving while intoxicated. The driver received a reading of .17 alcohol concentration. He was booked at the Hennepin County Jail for gross misdemeanor 3rd degree DWI (over .16) and misdemeanor 4th degree DWI.

A 58 year old male reported that his daughter's boyfriend physically assaulted him inside his home. The suspect was identified as a 29 year old male. The area was checked, but the suspect was not located. The victim was provided a citizen's arrest form. When officers returned, the victim stated he changed his mind and did not wish to pursue charges.

The manager reported that an iPad used for reservations was taken from the front hostess stand. Security footage was reviewed of the theft. The serial number was received and entered into the computer. Loss value undetermined at this time.

Vehicle accident, see state report. One driver was arrested, cited and released for operating an uninsured vehicle.

A 31 year old female reported that one of her license plates had been stolen and another plate left in its place. The plate left on the vehicle came back as stolen out of Washington County. The victim was advised to obtain new plates and her license plate would be entered into the computer as stolen. This stolen license plate was recovered a few days later this license plate was recovered in Chisago - no arrests.

Officers observed a suspicious vehicle. Routine checks listed an alert on the vehicle in relation to a theft in Washington County. Two occupants were ordered from the vehicle. The male was identified and later released. The passenger was identified as a 35 year old female. The female had three outstanding felony warrant for drugs and theft from Hennepin County, Dakota County and Carver County. The female was also listed as a suspected in the Washington County theft. Stolen property was recovered from inside the vehicle. Cottage Grove PD was advised of the recovery. The female advised she had eaten methamphetamines' and an ambulance was called. She was transported to the hospital for evaluation. Hennepin County deputies were advised of her location and the warrants.

Officers received a call to an assault in progress. Information was received that the suspect fled the scene and a vehicle description was received. The area was checked, but the suspect was not located. The victim, a 43 year old male, advised that a former co-worker entered the business and started yelling at him and began striking him with a baseball bat multiple times. The victim's injuries were photographed, but he refused medical attention. The suspect was identified as a 40 year old male. Officers responded to the address and the suspect came out peacefully. The suspect was questioned and placed under arrest. Prior to transport, the suspect complained of dizziness and collapsed. The suspect was transported for evaluation. The victim completed a witness statement, a citizen's arrest, and requested the suspect be trespassed.

Employees reported that a female suspect concealed items in a bag and left without paying for the merchandise. Estimated loss value \$191.71. A description of the suspect was received. Employees advised this female is suspected of stealing merchandise over the past two months.
