The suspect began driving away as the victim hung onto the door frame causing his feet to drag on the pavement. The suspect continually punched the victim in the face and hit him with the driver's door. The victim fell from the vehicle a few blocks later. The victim was transported to the hospital for treatment. An alert with a vehicle description was sent to the metro area. The victim's vehicle was processed for possible evidence. One credit card had been used and there was another attempted transaction. Investigation lead to the arrest of a 23 year old male for robbery, criminal vehicular operation and financial transaction card fraud.</p>
