



GUIDE TO RUBBISH, RECYCLABLES, YARD WASTE & DUMPSTERS (FLEXIBLE & SOLID)

HOW TO USE THIS GUIDE:

St. Anthony city codes are designed to prevent offensive or harmful conditions and activities for St. Anthony Village residents and business owners. It is the resident's responsibility to adhere to the code. This document provides the primary requirements and expectations.

This guide is specific to the many of the issues of commercial and residential rubbish, recycling and dumpsters.

DESCRIPTION	GENERAL REQUIREMENT
KEY DEFINITIONS	<ol style="list-style-type: none">Dumpster<ul style="list-style-type: none">- Non-flexible metal, composite or other hard-sided container with holding capacity exceeding five (5) cubic yards and used for temporary storage of special pick-up refuse.Dumpster, Compact<ul style="list-style-type: none">- Metal, composite or other hard-sided container with a holding capacity not exceeding five (5) cubic yards and used for temporary storage of special pick-up refuse.Dumpster, Flexible<ul style="list-style-type: none">- Flexible container with holding capacity not exceeding five (5) cubic yards and used for temporary storage of special pick-up refuse.- Commonly used terms: "dumpster bag," "soft-side dumpster," or "waste removal bag"- Used in lieu of a metal front or rear- load or roll-off dumpster.Recyclables<ul style="list-style-type: none">- Materials which may be recycled or reused through recycling processes- Includes metal beverage containers, glass, newsprint, plastic bottles with necks, corrugated cardboard, magazines, catalogs, phone books and any other materials designated as recyclables by City Council resolution.Rubbish<ul style="list-style-type: none">- Miscellaneous waste materials resulting from housekeeping, mercantile enterprises, trades, manufacturing, offices including garbage, refuse and trash.Yard Waste<ul style="list-style-type: none">- Grass, grass clippings, bushes, shrubs, tree branches less than four (4) inches in diameter, and clippings from bushes and shrubs that come from residential, commercial/retail, institutional, or industrial sources as part of maintaining yards or other private or public lands.- Does not include construction, renovation, and demolition wastes or clean wood.
CONTAINER STORAGE & LOCATION REQUIREMENTS	<ol style="list-style-type: none">General Requirements<ul style="list-style-type: none">- Every occupant shall store and dispose of or recycle all refuse rubbish and recyclables in a clean, sanitary, and safe manner complying with City ordinances.- Every owner of an apartment building must supply facilities for sanitary and safe storage and disposal or recycling of refuse and recyclables.- Storage of rubbish/recyclables/yard waste collection containers must be to the side or rear-yard setback, next to a structure on property where collection is made.Refuse, Recycling, and other Waste Containers<ul style="list-style-type: none">- Collection containers and dumpsters for multiple family residential, commercial, industrial and institutional uses must be screened on all four (4) sides.- Enclosure height must be at least one (1) ft. above the top of the container.- Rubbish enclosure must be constructed of materials harmonious with those of the principal structure with a minimum opacity of 90%. Enclosure gate or door must be kept closed except when accessing container(s)Front Yard Containers<ul style="list-style-type: none">- Rubbish and recycling containers may be kept in a front yard in an approved and permitted screening structure (Section 150.073) and must have a solid screening effect.


	<ul style="list-style-type: none">- Enclosure height must be at least three (3) inches above tallest container inside it.- Screening structure must be no closer than three (3) ft. from property line and no closer than 15 ft. from road where collection is made.- Structure size cannot exceed 78" wide by 40" deep. Design, materials and location must be reviewed prior to issuance of City Zoning Permit. <p>4. Flexible & Compact Dumpsters</p> <ul style="list-style-type: none">- Only solid rubbish or matter (no liquid waste) can be disposed of such as construction or demolition debris, discarded household goods or wares, cardboard or packaging waste, or the like.- Cannot be placed on street and must be located behind the street curb.- Cannot be placed within or block any portion of a sidewalk, path or trail.- Cannot be closer than five (5) ft from side or rear property line.- Must be placed within 15 ft of a water/fire hydrant.- Cannot remain on property more than 14 days from the date it was placed.- Must be collected by a waste hauler or otherwise removed within one (1) week of the container being filled to its capacity.- No more than two (2) flexible/compact dumpsters can be kept on property at any one time.- All rubbish must be completely and securely placed inside container; and cannot exceed top of container sides. Rubbish in container cannot extend outside container beyond plane of the street curb line.- Any refuse that falls or is blown out of container must be promptly collected/picked up and properly stored.

Outdoor Storage location requirements for R1, R1A, R2, R3 zones


1- Corner properties where collection is made from side yard setback; containers unless screened, must be kept behind side-lot structure (indicated by green shaded area)

2- Properties where collection is made from front-yard setback, containers, unless screened must be kept behind front yard setback (indicated by green shaded area)

1-Side Yard Collection




2-Front Yard Collection
