


How are property taxes used?

City property taxes are the main source of revenue for most cities; for St. Anthony Village, 65% of operating revenues come from property taxes. The property tax statement that is sent from the county that you live in will also include other taxing jurisdictions such as the county itself, the school district that serves your area, and the watershed district in which the property is located.

The City portion of St. Anthony's property tax is shared between the General Fund Budget, Road Levy Taxes, Tax Abatement, and Capital Improvements.

Property taxes are based on home valuation. The median valued home for Hennepin County homes in St. Anthony for 2023 was \$411,250. For a property at this value, the St. Anthony portion of the tax bill was \$2,560.18 distributed as demonstrated in this **TOTAL CITY TAXES** pie chart.

St. Anthony Village Exploring Falcon Heights Police Contract

The City of St. Anthony Village is exploring the potential of providing police services to the City of Falcon Heights starting in January 2025.

St. Anthony Village currently provides contract policing services to the City of Lauderdale and previously provided contract law enforcement services to Falcon Heights from 1994 through 2017. That contract was terminated following the shooting death of Philando Castile by a SAPD officer in July 2016.

Falcon Heights has contracted with the Ramsey County Sheriff's Office since January 2018 with that contract set to expire at the end of 2024.


This collaboration is invaluable in selecting priorities and fostering a culture of trust up and down the organization.



The **General Fund** (66% of total levy) funds the main operations of city services. This portion of the levy is distributed as demonstrated in this pie chart.

Household Hazardous Waste: Declutter chemicals for a fresh start



Sprucing up your home should include properly cleaning out unwanted chemicals. Don't

wait to declutter. Check for potentially hazardous items under the sink, storage closets, and in the garage. Keep what you would use in the next year and put everything else in a box to drop at one of Ramsey County's household hazardous waste collection sites.

Ramsey County's household hazardous waste collection sites are your one-stop, drop-off for most products labeled caution, warning, danger, or poison. Residents can bring automotive fluids, batteries (all types), cell phones, cleaners, fluorescent lights, paint, pesticides, propane tanks, and more for free.

Ramsey County has a year-round collection site in St. Paul and a mobile collection that moves to a different community monthly, April through October. Find hours, directions, and the full list of items accepted at RamseyRecycles.com/HHW.

Aspen Service & Programs

Residential service levels are defined by container size and these sizes determine the rate that each resident will be charged for their trash service. Please

note that additional charges may be assessed if the lid is open more than 6." Aspen drivers do not assess overflow bag charges readily, but will for situations where bags are stacked on top of the cart or when there are bags on the ground. If overflow bags are something you have often, please contact customer service (612-883-8008) to inquire about changing your service level to better accommodate your trash needs.

State law prohibits mixing yard waste and trash.

Aspen drivers will not empty a cart if yard waste material (i.e. grass clippings, brush, leaves or other plant material) is mixed in. If this happens, Aspen will not return to collect your trash until your next service day unless you request a special pick-up for an additional charge. Aspen offers on-call and scheduled yard waste collection April through November, weather permitting.


UPDATE: St. Anthony Village Climate Plan Adopted

The City adopted a 5-year Climate Plan in December of 2023, breaking initiatives into four categories including [water, waste, energy, and transportation](#). The Climate Plan will encompass City operations and also include action items for residents and businesses collaboration.

St. Anthony Village built on its history of sustainability leadership by developing this Climate Plan last year. According to the goals established in the SAV 2040 Comprehensive Plan, the City goal is to reduce city-wide CO₂ emissions by 80% and city facility CO₂ emissions by 100% (over a 2005 baseline) by 2040.

During annual goal setting meetings, implementation of our plan was discussed and resources assigned. The City will be hiring a Sustainability Coordinator this spring.

St. Anthony Village Announces New Police Chief Jeff Spiess and Department Promotions

The City of St. Anthony Village has announced the appointment of Jeff Spiess as the new St. Anthony Police Chief. Chief Spiess, a 25-year member of the department, replaces Jon Mangseth who retired in January after 29 years of service.

The new St. Anthony Police Chief is a familiar face to community members as an officer with the department since 1998. During his time as an officer and Sergeant, he served as a DARE Officer, a Community Engagement Officer, and as a Drug Recognition Expert. Following his promotion to Captain in 2016, he was responsible for day-to-day-operations and supervised the Investigative Team.

"We are confident that Chief Spiess will provide a seamless transition for the department and for the City," says Charlie Yunker, St. Anthony City Manager.

"The Chief has strengthened the department with numerous innovations and

achievements throughout his tenure." Among his many accomplishments, Spiess led the initiative for grant funding from the U.S. Dept. of Justice to assist in the purchase of Body Worn Cameras and the implementation of that program. He also introduced mentorship programs that pair veteran officers with new officers to assist with the adjustment to life as a St. Anthony police officer. Most recently, Chief Spiess and his staff launched a Cadet program and formed a Recruitment Team as part of a forward-looking effort to staff the department for the future.

Spiess is a graduate of the Police Staff and Command program through Northwestern University Center for Public Safety (2023), and holds a M.A. in Organization Leadership, Bethel University (2014), and a B.S. in Law Enforcement, Metropolitan State University (2011).

MIKE HUDDLE PROMOTED TO POLICE CAPTAIN

Captain Huddle joined the department in 1999 and has served in a variety of capacities. He was a Community Engagement Officer, and a 15-year member of the SWAT team among several other roles. He has received numerous honors including the St. Anthony PD Medal of Honor Award, the MN Chiefs of Police Medal of Honor Award, the MPPOA Police Officer of the Year Honorable Mention, and the Tactical Officer of the Year Award. Most recently he has led the department's Community Engagement Team. *Congratulations Captain Huddle!*

Sergeant Hess began his career with the department in 2016 and served as a volunteer reserve officer prior to that. St. Anthony Village Exploring Police Partnership With City of Falcon Heights

Falcon Heights is seeking a long-term partnership for its policing services beginning in 2025 and believes the St. Anthony Police Department is a good fit for several reasons: level of service, physical proximity, logistics, financial considerations, and – most importantly – the clear commitment the SAPD has to practices that align with the values of Falcon Heights residents.

The SAPD is currently authorized for 20 sworn officers, increasing to 22 on July 1, 2024. If the partnership moves forward, St. Anthony Village will add additional positions to support the expanded area while maintaining the high level of service the St. Anthony Village and Lauderdale communities currently receive.

UNDERSTANDING THE PROCESS

The Falcon Heights and St. Anthony Village City Councils met in a joint workshop Feb. 8 for an initial discussion about a potential police services partnership. No formal action was taken during the workshop. Council members from both cities expressed initial interest in beginning a multi-phase process to explore a renewed partnership.



COMMUNITY FEEDBACK

Council members agreed that the first phase of the decision-making process will focus on community engagement throughout the month of March, expressing the importance of gathering and listening to feedback, questions and concerns from residents, City staff, SAPD officers, and other stakeholders.

JOINT TOWN HALL SCHEDULED

The City Councils for both communities have scheduled a Joint Town Hall for residents and community members to ask questions, and share their feedback and concerns.

PUBLIC SAFETY

New Medical Response in St. Anthony Village | Mattie Jaros, St. Anthony Fire

Historically in St. Anthony, when you call 911 for a medical emergency, you will get a Fire Department response. Firefighters provide medical care with our extensive training and equipment until an ambulance arrives on the scene to take over patient care and transport to the hospital.

In February last year, the St. Anthony Fire Department partnered with Hennepin County Medical Center to develop an Advanced Life Support (ALS) program. This program provides St. Anthony Fire Department Paramedics with the ability to fill a response time gap caused by staffing and a heavy increase in call volume.

GRANT PROVIDES LIFE-SAVING HEART MONITOR

We also received a grant from the [Gary Sinise Foundation](#) to purchase a heart monitor. This extremely valuable tool allows us the ability to take a 12-lead ECG of the heart. Additionally, we were given variances to start IVs, administer various medications, and provide critical life-saving procedures. For example, if someone calls 911 because they are having chest pain, this monitor helps provide a picture of the heart, and can help rule out or confirm a cardiac event. The paramedic on shift can then start an IV and give medication and fluids per the new program.

NEW PROGRAM SAVES CRITICAL TIME

We have already seen great success with this program as there have been many critical calls where the fire department has been able to evaluate the issue, start an IV, give medications, and prepare the patient to be transported to the hospital; tasks that typically were done by the incoming ambulance. This saves valuable time and increases a positive outcome for our patients. This past year the St. Anthony Fire Department ran over 1,839 calls (our busiest year on record!). Of those calls, approximately 629 were deemed to need the Advanced Life Support level of care. This continues our goal to provide the best care we can to our community.

Join the Adopt-a-Drain program to "adopt" a storm drain in your neighborhood.



Using reclaimed rainwater captured from a rain barrel to water your lawn and garden is a great way to practice sustainability and protect your local environment. The city provides an opportunity each year for residents to participate in a rain barrel program. Barrels are repurposed from oak wine barrels and then sold to residents at a reduced price of \$100.

US Internet Fiber Installation

This year, US Internet will be installing fiber conduit in the Silver Point Park neighborhood and areas along the south side of 37th Avenue off of Harding Street and Edward Street. The fiber conduit will be bored underground in the city right-of-way and flat junction boxes will be placed throughout the project area. The contractor is required to restore any disturbance caused by construction activities and the City will continue to work with USI to ensure yards are restored.

Inflow & Infiltration Inspection Reminder

Are you planning to sell your home or business?

Prior to listing your home for sale, you must complete two I/I inspections:

- Sanitary Sewer Line Inspection Video
- Sump Pump Inspection

WHY IS THIS REQUIRED?

- to help reduce peak sanitary sewer flows caused by Inflow & Infiltration.
- to prevent excess clear water from causing I/I problems and from sapping sanitary sewer capacity needed for wastewater
- to prevent sewer backups and increased costs for needlessly putting clear water through the wastewater treatment process.

NOTE: I/I Inspections are also required as part of our rental licensing program



>> MET COUNCIL FUNDS AVAILABLE

Owner occupied properties are eligible to receive funds to help with private lateral repairs or replacement.

- Not available for initial televising
- Work must occur by Dec. 31, 2024
- Grant applications accepted May 1 - May 31, 2024

Harding Pond Stormwater Quality Improvement Project

Stormwater ponds are best management practices (BMPs) designed to collect and store stormwater runoff; helping to regulate flow through the stormwater infrastructure and provide water quality treatment. When it rains, the stormwater runoff will collect sediment, pollutants and other debris as it flows through the various curb, gutter and storm sewer systems on its way to the pond. Each stormwater pond is designed to have a roughly 25-50 year lifespan, which includes periodic maintenance to preserve its functionality.

The City's contractor removed 2,600 CY (cubic yards) of nutrient rich material from Harding Pond in 2023. Completion of the project will increase flood protection to homes adjacent to Harding Pond by providing additional flood storage. The shoreline was constructed with safer slopes and vegetation that benefits pollinator species, bees and butterflies, and improves the quality of water being sent downstream to the Mississippi River.



This spring, the City will install an aerator in the pond to push high volumes of water into the air increasing the overall health of the pond and keeping it thoroughly mixed. This introduction of oxygen and water movement breaks up stratification, eliminates odor, discourages algae growth, and promotes a healthy aquatic environment.

2024 Street and Utility Improvement Project

The 2024 Street Improvement Project includes asphalt resurfacing (mill and overlay) improvements along the majority of St. Anthony streets. Bids were received on February 2nd and it is anticipated the Council will award the contract in April. The project documents are currently being executed with an anticipated start date of late spring/early summer depending on weather.

Hennepin County Silver Lake Road (County Road 136) Chip Seal Improvements



Each year, Hennepin County completes maintenance work to keep the road surface in good repair, to extend the life of the pavement, and to take care of roadway assets. Silver Lake Rd. (County Rd. 136) from 37th Ave. NE (County Rd. 93) to St. Anthony Blvd. and Kenzie Terrace (County Rd. 153) has been identified to be chip sealed in the summer of 2024. Chip seals apply a thin layer of asphalt and aggregate that seal the surface of an asphalt pavement. This protects the pavement from the effects of sun and water, increases skid resistance, and fills small cracks and other surface defects.

Generally, maintenance projects last only a few days to a couple of weeks, and most don't require full closures or detours. The exact schedule for the work along Silver Lake Rd. will be set a few weeks ahead of time, and is subject to weather, nearby construction detours, and other factors.

St. Anthony Village, like most communities, maintains a set of land use regulations. These regulations are codified in the City Code as the Zoning Ordinance (Sec. 152) and the Subdivision Ordinance (Sec. 153). The codes set standards for the types of land uses – identified by zoning district – as well as dimensional or “performance” standards. Standards can be general across different districts, or may be specific to uses within a zoning district.

As is true for virtually any general standard, certain conditions can be present which justify departure from those standards. When the departure is for a type of land use, the departures are made through a zoning category called *Conditional Use Permits*. When the departure is proposed from a dimensional standard, the process is a *Variance*.

PUBLIC PROCESS FOR CONDITIONAL USE PERMITS & VARIANCES UNIQUE TO LOCAL GOVERNMENT

Conditional Use Permits and Variances each have their own code-defined rules that inform how the City’s Planning Commission and Council evaluate requests. Decisions are required to meet a legal standard known as *rational basis* and cannot be arbitrary or untethered from the City’s overall goals. When a project is proposed to vary from the baseline requirements, there is a common public process that provides local community members and neighbors the opportunity to comment on the proposal. This process is an aspect of land use management that is unique in local government.

CITIES CAN ONLY DO WHAT STATE PERMITS

For the vast majority of those functions, the City must do so in open meetings. Land use decisions take this one step further – public hearings are published, and property owners in the immediate vicinity of a project location are provided mailed notice of the proposal.



WHY DO WE HOLD PUBLIC HEARINGS?

Public hearings are intended to inject local knowledge of factual conditions that may impact a proposed project’s design, intensity, or many other aspects. City officials use that local

knowledge in crafting a decision that does the best job of meeting the City’s land use policies.

MAINTAINING OUR UNIQUE VILLAGE ENVIRONMENT

Minnesota’s land use regulations help ensure a variety of urban and suburban landscapes, variable and distinctive to each community. Public participation and local decision-making are key to maintaining that variety, and an instrumental part of St. Anthony’s unique village environment.

St. Anthony Participating in Just Deeds Project

During the formation of the Twin Cities, discriminatory covenants were used to keep those who were not white from owning or occupying land in certain neighborhoods. The result is a century of segregated communities and disparities in wealth, health and well-being.

The Just Deeds program allows property owners to discharge racially restrictive covenants to create change and promote racial equity here in Minnesota.

Each year, the City Manager and department heads present their Annual Reports at a City Council meeting. The Liquor Operations report highlights notable trends, sales and profits.

The final audit for 2023 has not been completed at the time of this publication's release; but early indicators show that our liquor store's sales in 2023 were \$7,065,950 and profits were \$381,780.

SALES UP SLIGHTLY, EXPENSES UP SIGNIFICANTLY

2023 sales increased slightly while expenses increased significantly. Inflationary cost increases of non-inventory items such as utilities, repairs and maintenance, etc. impacted our profits. Wages and benefits also increased as we work to attract and retain employees. Total operating costs increased \$103,800.

MAXIMIZING PROFITS

Our staff works hard to maximize profits within the current retail environment.
